Child and Family Protective Services

The Texas Department of Family and Protective Services (DFPS) has a central place to report:

- Child abuse and neglect.
- Abuse, neglect, self-neglect, and exploitation of the elderly or adults with disabilities living at home.
- Abuse of children in child-care facilities or treatment centers.
- Abuse of adults and children who live in state facilities or are being helped by programs for people with mental illness or intellectual disabilities.
 These are run by the Texas Department of State Health Services (DSHS) or Texas Department of Aging and Disability Services (DADS).

Texas law says anyone who thinks a child, or person 65 years or older, or an adult with disabilities is being abused, neglected, or exploited must report it to DFPS.

A person who reports abuse in good faith is immune from civil or criminal liability. DFPS keeps the name of the person making the report confidential. Anyone who does not report suspected abuse can be held liable for a misdemeanor or felony. Time frames for investigating reports are based on the severity of the allegations. Reporting suspected abuse makes it possible for a family to get help.

District Safety & Security Site Bae Committee Meetings

Statement of Purpose: It is the purpose of East Fort Worth Montessori Academy (EFWMA) Safety and Security Committee to collectively engage staff, students, and community in developing a safe working and learning environment, so that great teaching and authentic relationships can occur. Due to our small size, our Safety Security Committee also serves as our Site Base Decision Making Committee (SBDM), and our School Health Advisory Committee (SHAC)

We meet 3-4 times a year

School Procedures for Point of Entry

- Safety is a priority at EFWMA, we will implement safe procedures to ensure the safety of our students and staff.
- Before gaining access in the building, visitors will be screened by using the access technology to call the front office. An ID must be shown with a reason for the visit before entry into the vestibule is allowed. All business is conducted from the vestibule. If a parent is on campus to eat with their child, the front office manager will have a list of parents who made a request two weeks ago.
- All visitors are required to present identification which are run through the Raptor system which provides alerts for registered sex offenders.
- A criminal background check is conducted on all EFWMA volunteers and employees.
- All employees are required to wear EFWMA school identification badges.
- All major and minor exits/entrances are locked throughout the school day. Any unlocked door should be reported. An investigation will be conducted. The offender will be disciplined according to the local board policy.
- No one is allowed to keep doors propped open, if you observe such practices please notify the front office and the campus principal.
- EFWMA has video surveillance cameras in the interior and exterior of the building.
- EFWMA utilizes an emergency notification system to communicate with staff and parents through either emails or phone calls, whichever is most appropriate for the situation.
- EFWMA conducts safety drills throughout the school year involving both students and staff. We keep a log of all practice drills. A Corrective Action Plan is developed if the drill conducted had gaps. The drill is re-done within five days of the corrective action plan.
- The district has a Crisis Management Plan that is evaluated and updated.
- EFWMA partners with local law enforcement and first responders are a part of the school safety and security committees.

 Starting two years ago, the school employed an independent tactical security auditor to audit the school and support the development of all safe and secure plans.
