Dear Parents,

As we prepare for enrollment for the 2024-2025 school year, we want to share important updates regarding the Cub House hours. We are excited to announce that the Cub House will now offer both early and after care for our families. This is a change to our current program in that the church nursery will no longer house our early Cub House arrivals. Briarwood church nursery will still be available for parents attending Bible studies, or who may need occasional drop-in care during school programs and events. We are so grateful for this ministry of the church and how well they partner with us to love these little ones well!

Another change we will be making to our hours is regarding our after care program. We will now be offering extended care for our students until 4:30 p.m. You may sign-up for Session A (1:00-3:00), or Session B (3:00-4:30), or a combination of the two. Further details are included below.

It is our hope and prayer that this news will come as an exciting update for your family. Consistent, Christ-centered, trustworthy care for your children is our priority!

We will begin our enrollment with current students. If you'd like for your child to stay with us in the Cub House next year, please email me directly at abryant@bcsk12.org to let me know. I will then send you a ProCare bill for the \$100 non-refundable registration fee. This will be a separate bill from your tuition and will need to be paid by January 22, 2024. If your child is in our program currently, they are guaranteed a spot for next year with this registration.

After we move all of our current students to their new classroom assignment, we will open our enrollment to current students' siblings. I will send you an email link to this registration for your new student, and you will pay the \$100 registration fee through that link as we've done in the past. Spots for siblings are not guaranteed, but are highly probable and will receive the highest priority. This link will be sent to you on **January 23, 2024 at 10:00 a.m.** to the email address(es) provided in ProCare. During this time, you will only need to register your NEW child that has never attended our program before. Your current child will already be registered.
