

Guaranteed Admission Program Student Data Sharing Agreement

The Sumner - Bonney Lake School District (SBLSD) is partnering with seven Washington colleges and universities through a Guaranteed Admission Program. This program is designed to create greater access to higher educational opportunities for seniors. Guaranteed admission is not free admission. To participate in the Guaranteed Admission Program, you must give consent for SBLSD to share your educational information with participating institutions. The purpose of this form is to give the participating institutions the necessary information to use in the eligibility and admission process, including contact information. Your data will not be shared with organizations other than the ones listed below. The institutions will reach out to you directly with admission information.

To qualify, students must:

- 1. Meet GPA and course requirements.
- 2. Release their contact information to higher education institutions.

Data to be Shared with Institutions:

- Date of Birth
- Email(s) on record (school, personal)
- Mailing address
- Unweighted cumulative GPA

I understand that the Family Educational Rights and Privacy Act (FERPA) protects the confidentiality of my student's education records ("Education Records") and that the Sumner - Bonney Lake School District may only release these records to third parties with my prior written consent or as otherwise permitted by law. Intending to waive my right to confidentiality, I consent and direct the Sumner - Bonney Lake School District to release information from my Education Records to the organizations listed below.
