SCHOOL BOARD MEETING

February 2, 2016

The School Board met February 2, 2016, at 7:00 p.m. in the Superintendent's Office. Members present were Joe Hufford, Mark Humrickhouse, Joe Mink, Billie Roth, and Nathan Root. Also present were Superintendent Dr. James Hanna, Mike Gick, Karla Metzler, Anna Wieseman, and Mandi Pennington.

A motion was entered by Nathan Root and seconded by Joe Mink to approve claims 56-111, the payrolls dated January 15 and January 29, 2016, and the minutes of the January 12, 2016 Regular Session and Board of Finance meetings . The motion carried 5-0.
