May 5, 2020

The School Board met on May 5, 2020, 7:00 p.m. via Livestream (https://youtu.be/maHt5Ol5Kg4) due to the "State of Emergency" during COVID-19. Members present were Joe Hufford, Nathan Root, Mike Emens, Nathan McCullough, and Jennifer Jacoby. Also attending the meeting were Superintendent Dr. James Hanna, Dustin Shadbolt, and Mandi Pennington. There were seventeen (17) viewers who joined the livestream meeting.

A motion was entered by Nathan McCullough and seconded by Mike Emens to approve claims 15407-15500, the payroll dated April 17, 2020, and board meeting minutes from April 7, 2020. The motion passed with a roll call vote 5-0.

The Board considered the issuance of one or more BANs approved by the Rossville Consolidated School District Building Corporation at a meeting held on May 1, 2020.
