## October 6, 2020

The School Board met on October 6, 2020, 7:00 p.m., at Charles E. Whitlock Administration Building. Also attending the meeting were Superintendent Dr. James Hanna, Karla Metzler, Brooke Meeks, Terry Thompson, and Mandi Pennington.

A motion was entered by Jennifer Jacoby and seconded by Nathan McCullough to approve claims 15915-16016, the payrolls dated September 18 and October 3, 2020, and board meeting minutes from September 8, 2020. The motion carried 4-0.
