SCHOOL BOARD MEETING  
November 10, 2020

The School Board met on November 10, 2020, 7:00 p.m., at Charles E. Whitlock Administration Building. Members present were Joe Hufford, Nathan Root, Mike Emens, Nathan McCullough, and Jennifer Jacoby. Also attending the meeting were Superintendent Dr. James Hanna, Karla Metzler, and Mandi Pennington.

A motion was entered by Mike Emens and seconded by Jennifer Jacoby to approve claims 16017 - 16136, the payrolls dated October 16 and October 30, 2020, and board meeting minutes from October 6, 2020. The motion carried 5-0.
