

ROSSVILLE CONSOLIDATED SCHOOL DISTRICT  
SCHOOL BOARD MEETING

August 18, 2020

The School Board met on August 18, 2020, 7:00 p.m. in the school's multipurpose room. Members present were Joe Hufford, Nathan Root, Mike Emens, Nathan McCullough, and Jennifer Jacoby. Also attending the meeting were Superintendent Dr. James Hanna, Terry Thompson, Karla Metzler, and Mandi Pennington.

A motion was entered by Nathan Root and seconded by Jennifer Jacoby to approve claims 15789-15818, the payroll dated August 7, 2020, and board meeting minutes from August 4, 2020. The motion carried 5-0.

The 2021 Budget, the 2021 Bus Replacement Plan, and the 2021-2023 Capital Projects Plan were reviewed. Permission to advertise on the DLGF website and the school's website was approved on a motion from Mike Emens and a second from Nathan Root. The motion passed 5-0. (ATTACHMENT I)

A motion was entered by Nathan Root and seconded by Jennifer Jacoby to reduce the current year's Operations Fund Budget appropriation to free up appropriation for the 2021 Operations Budget. The resolution was approved on a vote of 5-0. (ATTACHMENT II)

Advertising for additional appropriations for the Education Fund of \$100,000 and the Debt Service Fund of \$250,000 were approved on a motion entered by Jennifer Jacoby and seconded by Nathan McCullough. The advertisement will run in the Times and the Carroll County Comet on August 26, 2020, and the hearing will be on September 8, 2020.

The following personnel items were approved:

Anna Byrd – resignation effective August 11, 2020

Sherri Johnston – resignation dated August 14, 2020. Her last day will be August 28, 2020.

Sue Graham – abandoned custodial position, August 5, 2020.

Tarra Ziegler – appointment as the Intense Needs Teacher. Here base salary will be \$45,000 and her duties began, August 17, 2020.
