## REQUIREMENTS

1. Each applicant must submit a typed essay addressing the question in Part II. Essay must be at least one full page and not more than two pages, double spaced, size 12 font. Essays are photocopied for the judges to read, so please be sure it is legible. ***Illegible essays will be disqualified.***
2. The applicant must ensure that the sections that are completed by the Youth Minister and the Parish Pastor (in his absence the DRE) are completed ***without the applicant's name*** used in their documentation and ***no additional sheets attached. Failure to comply will result in disqualification.***
3. The applicant ***must not*** mention his/her name or make any other identifying reference within the essay. ***Failure to comply will result in disqualification.***
4. Each applicant must sign the Student Certification Statement on that the Essay is their own creation. Be sure to attach your Essay/theme answer to the packet.

Applications are reviewed and judged as follows:

**20%** - School activities: UIL programs, leadership positions, sports;  
Community: and the Institution that you plan to attend.

**30%** - Church activities: involvement in the Church and community

**50%** - Responding fully to the Theme:
