2. All prices must include transportation and delivery to the warehouse or school specified.
3. The Board of Education reserves the right to waive defects and informalities in proposals, to reject any or all proposals, or to accept any proposals as may be deemed to its interest, and to award either by item, combinations of items or all items to one vendor.
4. When applicable, the bidding vendor awarded must have a representative available for on-site visits if a special need arises or if there are any problems with the items bid.
5. Federal Excise Taxes or Kentucky Sales and Use Taxes are not applicable to any purchase made for use of the Pulaski County School District. Bids should not include any such taxes.
