# PAYMENT INSTRUCTIONS 2024-2025

All payments must be made using the **FACTS** Payment System including payment made-in-full. (PLEASE NOTE that entry into the **FACTS** Payment System will occur as **one of the steps in the FACTS SIS online enrollment process**.)

Within the **FACTS Payment System**, each family (or **each parent/ guardian making <u>separate payment</u>) will:** 

- Establish a FACTS Payment account
- Select a payment plan for 2024-2025
- Make an initial, **non-refundable**, deposit of \$2,500 for each student

Full tuition is due on or before **June 5, 2024**, to avoid additional charges. All other payment plans carry additional processing/installment fees as outlined below.

## Following are Payment Plan Options for 2024-2025:

- 1. <u>Payment-in-Full</u> **due on or before June 5, 2024,** with no additional processing fee. Credit card, check (payable to FACTS) or electronic check may be used. A fee of 2.95% will be charged for all credit card payments. Purchase of the Tuition Refund Plan of \$475 is highly recommended.
- 2. <u>Two Payments</u> **one payment in June 2024** and **one payment in January 2025** with a \$212.50 installment fee added to each of these payments. Credit card, check (payable to FACTS) or electronic check may be used. An additional fee of 2.95% will be charged for all credit card payments. Purchase of the Tuition Refund Plan of \$475 is highly recommended.
- 3. <u>Monthly Payments</u> **monthly payments (up to 10 months) will begin in June 2024 and end in March 2025** with an \$85 installment fee added to each of these payments. Credit card, check (payable to FACTS) or electronic check may be used. An additional fee of 2.95% will be charged for all credit card payments. Purchase of the Tuition Refund Plan of \$475 is highly recommended.

## **PLEASE NOTE:**

- 1. All payments for 2024-2025 will be set up to be made automatically through ACH or credit card payment. If you have questions, please contact the Business Office at 972-774-1772 x2235.
- 2. Accounts must be current on 8/01/2024 for student(s) to begin school. Any tuition refunds requested after 8/01/2024 will be subject to the terms of the Tuition Refund Plan. In addition, accounts must be current on 12/15/2024 for student(s) to return to school in January 2025.

## **TUITION REFUND PLAN \$475**

If purchased, the Tuition Refund Plan will refund 60% of the unused portion of the paid tuition should you decide to withdraw your student from school for any reason, and 75% will be refunded if the withdrawal is for medical reasons.
