

**ROSSVILLE CONSOLIDATED SCHOOL DISTRICT  
SCHOOL BOARD MEETING**

November 11, 2021

The School Board met on November 11, 2021, at 7:00 p.m. in the Charles E. Whitlock Administration Building. Members present were Joe Hufford, Nathan Root, Jennifer Jacoby, and Nathan McCullough. Also present were Superintendent Dr. James Hanna, Nathan Burkle, Chad Dennison, Mark Padgett, Deanna Padgett, Preston Padgett, and Cara Cornell.

The Spotlight portion of the meeting acknowledged the accomplishments of students of the District. A GaGa Pit was built by Andy Verhey on the playground with funds provided by the Rossville PAC. Preston Padgett was recognized for his accomplishments during the fall Cross Country season, culminating in him qualifying for the Indiana State Cross Country Championship.

Upon a motion entered by Nathan McCullough and seconded by Jennifer Jacoby, the minutes from October 12, 2021, payroll claims dated October 15 and 29, 2021, and the claims 17169 – 17256 were approved. The motion carried 4-0.

A public hearing was held for the additional appropriation that was advertised in the *Carroll County Comet* and *The Times* on October 27, 2021. After no comment was given, Jennifer Jacoby entered the motion to approve. Nathan Root entered the second. The motion carried 4-0. (ATTACHMENT I)

The motion passed 4-0.
