## ROSSVILLE CONSOLIDATED SCHOOL DISTRICT SCHOOL BOARD MEETING

August 3, 2021

The School Board met August 3, 2021, at 7:00 p.m. in the Charles E. Whitlock Administration Building. Members present were Joe Hufford, Nathan Root, Jennifer Jacoby, Nathan McCullough, and Julia Mink. Also present were Superintendent Dr. James Hanna, Terry Thompson, Chad Dennison, Jayden Brown, David Dickerson, Mike Dickerson, Karla Metzler, and Mandi Pennington.

A motion was entered by Jennifer Jacoby and seconded by Nathan McCullough to approve claims 16893-16949 payroll claims dated July 23, 2021, and the minutes of the July 19, 2021 meeting. The motion carried 5-0.

The following personnel items were approved on a motion from Julia Mink and a second from Nathan Root:

Dawna Brown - resignation effective July 30, 2021

Megan Robbins - not offered a "letter of intent to return"

Deanna Padgett - transferred to a vacant position

Nicki Bolinger - hired as Assistant Cafeteria Manager

Sabrina Conde - hired as a First Grade Teacher, base salary \$40,000

The motion passed with a vote of 5-0.

Section 1310 - Electronic Participation by Board Members in Board Meetings and Section 525 - Non-Public Student Participation in Public School was approved at second reading on a motion from Nathan Root and a second from Jennifer Jacoby. The motion passed 5-0. (ATTACHMENT I)

Section 516 requires the Board of Education to approve all transfer students. On a motion from Jennifer Jacoby and a second from Julia Mink the transfer students were approved. The motion carried 5-0. (ATTACHMENT II)

The Annual Financial Report was approved for publication between August 1 and August 15 on a motion from Julia Mink. The second was entered by Nathan McCullough. The motion passed 5-0. (ATTACHMENT III)

The Indiana Legislature passed Senate Bill 2 that requires the Board to review the school's school bus routes and school bus safety policies. On a motion from entered by Nathan Root and second by Jennifer Jacoby, the routes and the safety policy was approved. The motion passed 5-0. (ATTACHMENT IV)

The Board approved students riding buses in the closed construction area on State Road 26 could be dropped off and cross the closed road. The motion was entered by Nathan McCullough and seconded by Julia Mink. The motion passed 5-0.

Nathan McCullough entered a motion to approve a Memorandum of Understanding between the District and the Rossville Police Department. The second was entered by Jennifer Jacoby. The motion passed 5-0. (ATTACHMENT V)
