

ROSSVILLE CONSOLIDATED SCHOOL DISTRICT
SCHOOL BOARD MEETING

July 6, 2021

The School Board met on July 6, 2021, at 7:00 p.m., at the Charles E. Whitlock Administration building. Members present were Joe Hufford, Nathan Root, Jennifer Jacoby, and Julia Mink. Also attending the meeting were Superintendent Dr. James Hanna, Karla Metzler, and Mandi Pennington.

A motion was entered by Jennifer Jacoby and seconded by Nathan Root to approve claims 16749 - 16866 the payrolls dated June 11 and 25, 2021, and the board meeting minutes from June 1, 2021. The motion carried 4-0.

The Board approved a resolution to transfer \$332,662.64 from the proceeds of the Construction Fund to the Rainy Day Fund. This transfer will pay back the funds used to pay for the 2021 Bond Issuance. The motion was entered by Julia Mink and seconded by Nathan Root. The motion passed 4-0.
