

**REGULAR TEACHER CONTRACT**

*Prescribed pursuant to Ind. Code 20-28-6-3 as the regular and uniform contract for the employment of teachers pursuant to Ind. Code 20-28-6-4(b)*

This regular teacher contract ("Contract") is by and between the governing body of the **Avon Community School Corporation** ("Corporation") and **JENNIFER R. SHAYOTOVICH** ("Teacher"). **JENNIFER R. SHAYOTOVICH** is a teacher as defined in Ind. Code 20-18-2-22.

In exchange for the Teacher's services described below, the Corporation and the Teacher agree that:

1. The Teacher shall teach in the schools of the Corporation for the school term, beginning **02/23/2024** and ending **06/30/2025** on Ind. Code 20-28-6-2(a)(3)(A)
2. The school term described in paragraph 1 immediately above for services under this Contract consists of **114** workdays in the 2023-24 school year and **260** workdays in the 2024-25 school year. Ind. Code 20-28-6-2(a)(3)(B)
3. The number of hours per day the Teacher is expected to work under this Contract is 8. Ind. Code 20-28-6-2(a)(3)(E)
4. The Corporation shall pay the Teacher for services under this Contract the annual salary of **\$58,973.08** for the pro-rated 2023-24 school year and **\$134,500** for the 2024-25 school year. Ind. Code 20-28-6-2(a)(3)(C)
5. The Corporation shall pay the base salary in **11** installments for the pro-rated 2023-24 school year and **26** installments for the 2024-25 school year on a **biweekly basis**. Ind. Code 20-28-6-2(a)(3)(D) Ind. Code 20-28-6-5(1)
6. This Contract may be cancelled during its term for any of the grounds set forth in Ind. Code 20-28-7.5-1(b) pursuant to the procedures set forth in Ind. Code 20-28-7.5-2 and Ind. Code 20-28-7.5-3.
7. This Contract is a public record pursuant to Ind. Code 20-28-6-2(d) and Ind. Code 5-14-3.
