### Mission Statement

Valuing diversity and full inclusion, the mission of Cameron Ranch School is to ensure that each student becomes an informed critical thinker, strong communicator, and self-directed learner through personalized, rigorous instruction, utilizing technology, and modeling positive character traits in a safe, nurturing, respectful environment, in partnership with parents and community.

### School Profile

Cameron Ranch Elementary is nestled in the heart of Carmichael, California, a suburb of the Greater Sacramento Region. As the fourth-largest metropolitan area in California, Sacramento is considered "America's Most Diverse City" and our school reflects this distinction. Families in our community join us from over 20 countries/regions, 5 continents, speak nearly 20 different languages, and represent diverse abilities, skills, and talents that all add to the rich, cultural tapestry of our unique learning environment.

Cameron Ranch Elementary is one of several elementary schools in the San Juan Unified School District. The curriculum provided is aligned to the Common Core State Standards. The school supports cultural awareness on a daily basis through its diverse literature selections and other school activities. The school staff engages in ongoing work to strengthen our understanding and actions in support of diversity, equity and inclusion.

As a full inclusion site for children with developmental disabilities, Cameron Ranch is dedicated to developing the individual potential of all students. We believe that each student has the right to be successful academically and socially. We encourage and regularly craft lessons to align with equity and social justice standards to bring awareness to our diverse population, which is reinforced as a community responsibility. Staff and the greater school community work together to share knowledge and ideas to provide a rich learning environment for students.

We base our school behavior and discipline on the Positive Behavior Intervention and Supports (PBIS). We implement Responsive Classroom strategies and structures to provide a positive community of learners in every classroom. Students learn social skills and problem solving through Second Step curriculum lessons in our classrooms, as well as provide targeted skills groups in tandem with our school counselor and community intervention assistant. We provide a tiered system of behavior supports including social skills practice, check-in/check-out, individual behavior charts and positive rewards.

The Cameron Ranch principal, teachers, and staff value diversity and excellence. Our mission is to educate and inspire each student to succeed and responsibly contribute to a radically evolving world by providing innovative, rigorous, student-focused instruction and programs in a safe, caring, and collaborative learning community.

We respond to students' academic needs through the analysis of data, which addresses the individual needs of each student. We use scientific, research-based programs in literacy and mathematics with the belief that every student can learn to read, write, comprehend and compute. Within our programs, we differentiate instruction employing a number of strategies to meet the varied needs of individual students.

Cameron Ranch is a data-driven school. All staff members regularly engage in powerful discussions and data analysis to meet the needs of our students. Staff gathers formative assessment information during daily instruction to target learning for each student. Ongoing data analysis provides teachers with information needed to plan focused instruction and provides internal accountability. Teachers are able to measure and monitor student progress using academic and SEL (social emotional learning) data so that instruction is precise and personalized.

We ensure that all students have access to core curriculum, all teachers are highly qualified, and interventions are checked frequently for proper placement of students. Teachers provide differentiated instruction based on Common Core State Standards.

Cameron Ranch is piloting a robust field trip program with the school district, providing hands-on interactive learning opportunities for all students in grades TK-5 including our SDC/ILS classes at not cost to families. The benefit of such significant experiences bridges real-life applications to the skills taught within the school's walls. The program also strengthens community and allows opportunities for families to connect and forge friendships.

We pay close attention to the culture and climate of our school. We provide varied opportunities for our students to learn in an environment that is safe and fosters personal and academic growth. We involve students in empathy-gathering sessions and surveys to gain insight into their perspectives and provide the same opportunities for families to share thinking, needs and desired supports. The school responds to the needs identified in the empathy gathering sessions and surveys to close the communication loop and move forward with relevant and timely action steps.

Cameron Ranch staff holds high expectations for all partnership groups. We practice the following beliefs: that every person is unique and has equal worth, that every student can and will learn, and that diversity is a valuable asset that strengthens and enriches our community. Through these multiple beliefs we have been able to meet the unique needs of our students and families, which strengthens our school community as a hub of support and well-being.

We believe that family involvement is the key to building a sound foundation that encourages academic and personal achievement. Our community is a collective of volunteers that support experiential learning activities and special events. Valuing the uniqueness of each individual in our shared community, the focus of Cameron Ranch Elementary is to actively cultivate a healthy learning environment that allows students to grow into informed critical thinkers, effective communicators, and curious students of the world around them.

Families are invited to join our community collaborative, CREATE (Cameron Ranch Elementary Action Teams for Education). Families are encouraged to support our four main CREATE teams (community, creative, academic, bright futures). Our school understands how much our families care about their children's educational experience, no matter how busy their lives become. We have many opportunities throughout the school season for the community to get involved, no matter how much (or how little) time they have to share. Whether you can assist with quick tasks remotely or take a few hours to join the educators for fascinating events, we rely on everyone's contributions to truly bring experiential learning to life.

Cameron Ranch strives to find ways to connect families to the learning experience thus developing an understanding of the classroom environment, how the instructional rigor is scaffolded for students throughout each day and how they can support their child's educational experience.

Professional development occurs weekly at Cameron Ranch. We provide time for grade-level collaboration and professional learning communities. We recognize the importance of ongoing teacher learning which is directly linked to instructional practices and strategies. Professional development around PBIS, Social-emotional and Mindfulness, Data Analysis, Foundational Math, UFLI, GLAD, i-Ready, Heggerty, Guided Reading, Running Records, and writing through the content area remain a priority and focus. Last year, the staff is took a deeper dive into the Science of Reading and data driven collaborative inquiries to guide customized instruction. This work will continue and expand throughout all grade levels. Staff actively works to bring real life examples and teaching points to ensure the standards are addressed, with commonly agreed upon essential standards. This work will remain in place for all Cameron Ranch students, and for the current school year, staff is engaging in professional development around targeted differentiated instruction and social-emotional learning, which includes the ongoing

model of The Responsive Classroom. All of these trainings support classroom teaching strategies, school and class organization, literacy instruction, intervention, conceptual mathematical understanding and assistance, as well as home, school and community partnerships.

Cameron Ranch offers an after-school Bridges program. Bridges After-School/ASSETs Programs provide homework support, enrichment and pro-social recreation in a safe and positive environment. The Bridges After-School/ASSETs Programs currently serve over 3,000 students, grades K-12, at 32 sites. Student success is supported through the implementation of each of the four components of the program, including homework support, enrichment/disguised learning, pro-social skills/recreation, and parent support and empowerment. Strong relationships between program staff, school staff, parents and students are key. If you are interested in this program please contact the school office.

## 2023-24 Quality, Currency, Availability of Textbooks and Other Instructional Materials

San Juan Unified held a public hearing on September 28, 2021 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. ## School Facility Conditions and Planned Improvements

### General

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in October 2019 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Annually the district budgets \$2 million dollars for deferred maintenance activities.

### Age of School Buildings

### Maintenance and Repair

LEA maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient services and that emergency repairs are given the highest priority. Emergency work orders are addressed in the first 24 hours. Routine work orders are addressed within 30 days.

### Cleaning Process and Schedule

The LEA governing board has adopted cleaning standards for all schools in the LEA. Each site has a day and evening custodial crew. Each crew member has a run sheet with assigned responsibilities. A copy of these run sheets is available at the school office or can be obtained from Maintenance and Operations Custodial Services. Custodial Area Supervisors oversee the cleaning of all district sites to ensure cleaning standards are met daily providing a clean and safe site.

### Deferred Maintenance Budget

The LEA participates in the State School Deferred maintenance Program, which provides state matching funds on a dollar-for-dollar basis to assist LEAs with expenditures for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting and floor systems. For the 2023-24 school year, the LEA has budgeted 2 million for the deferred maintenance program. This represents 3% of the LEA's general fund budget.

Parents are a valuable asset to the entire school community. Through CREATE (Cameron Ranch Action Teams for Education), the school benefits from beautification projects, assemblies, fundraisers, student council, enrichment clubs, before and after school programs. Parents are also active on the School Site Council (SSC) and English Learner Advisory Council (ELAC) advising, exploring, and observing programs funded by Title 1 and LCFF money received from the state. ## 2023-24 School Safety Plan

### School Safety Plan

San Juan Unified School District emphasizes school safety and understands its importance in helping to achieve the academic success of its students. In accordance with the California Education Code, each school site must complete and maintain a Comprehensive School Safety Plan, to be reviewed and updated annually. The plan includes a review of safety data for the campus, safety policies, critical incident response & management information as well as emergency procedure information including those pertaining to incidents involving fire, earthquakes, intruders and other dangers. The review and update of the plan is a collaborative process involving representatives from site administration, instructional staff, custodial & classified staff, safety personnel and parent representative who together comprise a site safety team. Finalized plans are posted to site webpages for public access and presented to staff during training and development days no later than March 1 of each year. A copy of the plan is available for review in each school site office.

Safety drills are held on a regular basis and in compliance with the California Education Code to include fire drills, earthquake drills and intruder drills. Drills are coordinated and monitored with the assistance of the trained district safety personnel.

Safety is a shared responsibility. Each school site is supported by the district's Safe Schools Team. The Safe Schools Team is comprised of personnel specifically trained to support and promote school safety, provide advice to matters involving student welfare, assist in the coordination of drills and provide safety training to students and staff. Safe Schools Team members, known as Community Safety Specialists work collaboratively with site administrators and safety committee members to build and strengthen a culture of safety as well as address specific incident needs. The Safe Schools Team members are further supported through developed relationships with local law enforcement offices including the Sacramento County Sheriffs Department & Citrus Heights Police Department. San Juan Unified maintains contracts with local law enforcement for the purpose of employing uniformed law enforcement officers to further enhance school site security for special events as well as in response to critical incidents and threats. .

## Professional Development

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, Critical Literacy, TK-2 Reading, Supporting Independence and Engagement through Reading and Writing, Math to the Core, Expository Reading and Writing Course, and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level, and there are specific opportunities designed for our paraprofessionals to attend and be compensated. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
