# CALL TO ORDER

Mr. Peterson acknowledged a quorum was present and the meeting was called to order at 4:30 p.m.

# **BOARD AND STAFF INTRODUCTIONS**

Mr. Peterson welcomed any new attendees and sought introductions.

#### APPROVAL OF AGENDA

Ms. Bolognini moved to accept and approve the agenda as presented Ms. Mayes seconded. Motion passed 4 - 0  $\,$ 

#### **CONSENT AGENDA**

Approval of Minutes

Ms. Bolognini sought approval of the May 11, 2016 Regular Trust Board Meeting; motion seconded by Ms. Mayes. The motion passed 4 - 0.

#### INFORMATIONAL ITEM

Assistant Superintendents Update

Mr. Barragan stated that GESD administrators attended a three day PLC training on academic achievement. The training focused on implementing effective Professional Learning Communities in order to improve academic achievement for all students.

Mr. Barragan spoke about several renovations occurring throughout the district; Landmark installation of new gym floor and restrooms. Restroom renovations are also planned at American and Challenger.

The district is holding a ground breaking ceremony June 16, 2016 in honor of the new transportation building that was approved by voters in the last bond authorization.

Mr. Barragan talked about the summer meal program feeding anyone one-year to 18-years of age. Meals are served at 17 sites. Dr. Katie Wilson, deputy undersecretary for the United States Department of Agriculture visited our Summer Meal program. Dr. Wilson served lunch, and met with parents and children and later ate lunch with more than 100 children who attended the event at Ocotillo Rose Park.

Mr. Barragan informed the Trust Board of voters approving proposition (prop.) 123 and referred to Attorney General Mark Brnovich's opinion related to prop. 123 and how it was beneficial to Arizona public schools.

#### Claims Experience Review - Medical

Mr. Barragan stated in April, GESD incurred \$469,932 in medical claims which represents a monthly loss ratio of 75%.

GESD has incurred \$5,639,087 year-to-date in claims or a monthly average of \$592,129.

There are 12 claimants over \$75,000 and three that have exceeded the stop loss level of \$150,000; the projected refund is \$201,526.

Based on the trend we anticipate incurring approximately \$6,766,908 in medical claims or a loss ratio of 92% by June 30, 2016.

# Claims Experience Review - Dental

Mr. Barragan stated in April GESD incurred \$32,262 in dental claims or a monthly loss ratio of 76%. GESD has incurred \$427,892 year-to-date in claims or a monthly average of \$42,789. Based on the trend we anticipate incurring approximately \$513,468 in dental claims or a loss ratio of 103% by June 30, 2016.

#### Self-Insurer Workers' Compensation Guaranty Bond

Mr. Petricek discussed the premium, related cost and bond value for Willis Tower Watson (self-insured worker compensation) effective July 1, 2016 – June 30, 2017 as presented below.

Mr. Petricek discussed the premium and related cost for the Arizona School Risk Retention Trust, Inc. (ASRRT) annual planning document (APD) renewal premiums, including the Trust administration fee for property, casualty and liability insurance effective July 1, 2016 – June 30, 2017 as presented below.
