The Board of School Trustees of the Fort Wayne Community Schools met for the organization meeting in the Lester L. Grile Administrative Center on Monday, January 8, 2024, at 6:10 p.m. President Maria Norman, with there being no speakers on Public Comment Regarding Agenda Topics, called the meeting to order with the Pledge of Allegiance and the following members in attendance:

Election of Officers

Maria Norman opened the floor for nominations of officers. Julie Hollingsworth nominated Maria Norman for the office of President; Rohli Booker for Vice President; and Noah Smith for Secretary. The motion was seconded by Anne Duff. There were no further nominations and Maria Norman asked for a vote. Roll Call: Ayes, unanimous; nays, none. Appointment of Treasurer and Deputy Treasurers Dr. Daniel presented the following recommendation concerning the Appointment of Treasurer and Deputy Treasurers:

RELATED RECOMMENDATION: It was recommended that Sherry L. Nidlinger be appointed as treasurer, Stefan W. Pittenger and Elizabeth Riedinger as deputy treasurers for calendar year 2024, and that bonds for these positions be set as follows:

Deputy Treasurer \$50,000

It is further recommended that the administration be granted authority to execute any corporate resolutions required by the various banking depositories.

RELATED INFORMATION: IC 20-26-4-1 provides for appointment of a treasurer and deputy treasurers at the same time that the new Board organizes.

Ms. Nidlinger serves as the full-time treasurer for the corporation, Ms. Riedinger as the full-time deputy treasurer, while Mr. Pittenger serves the district as Director of Fiscal Affairs.

IC 20-26-4-5 provides that the treasurer and deputy treasurers give a bond for the faithful performance of duty in an amount determined by the governing body.

A motion was made by Anne Duff, seconded by Steve Corona, that the recommendation concerning the Appointment of Treasurer and Deputy Treasurers be approved. Roll Call: Ayes, unanimous; nays, none.

Board Member Julie Hollingsworth commented that graduation data came out for 2023 and she is proud to say that FWCS again exceeded the state average of 89%, with a 90% rate. Member Hollingsworth congratulated everyone from custodians, bus drivers, teachers and principals for a job well done, as they all have a positive effect on our students. Board Member Anne Duff hopes everyone had a great holiday.

Board Member Noah Smith congratulated FWCS graduate, from Snider, Jesse Bates for making the NFL All Pro team.

Superintendent Dr. Mark Daniel commented that Fiona Quinn is also an intern for the FWCS Communication & Marketing department. Today was a teacher in-service day. Graduation data shows we are moving the way we want to go. Earlier today, a small group worked on Portrait of a Graduate planning and implementation discussing attendance, graduation rate, freshmen on track to graduate, and behavior metrics and moving this data in a positive direction. Superintendent is excited to see what will happen over the next several years. We will be bringing to a future board meeting some exciting things happening with regards to some new grants that we have received. These concern Early Childhood.
