School Facility Conditions and Planned Improvements

An assessment of the campus facilities was done in October 2023 using the Facility Inspection Tool (FIT), which was selected by TUSD staff as a suitable tool for our bi-annual safety inspections to determine that a school facility is in "good repair. The school buildings and grounds of Cunningham School have been deemed to be 'clean, safe and functional', having no condition that poses an emergency or urgent threat to the health and safety of pupils or staff. Copies of the District Safety Inspections and Williams Inspections are maintained on file in the Turlock Unified School District Maintenance and Operations office. Safety: A safety plan is in effect. Certificated and classified staffs are vigilant in maintaining student safety. All staff wear identification badges, and all visitors check in and out at the school office. Cleanliness: Cunningham employs one full-time Lead Custodian who provides students and staff with a clean and safe school environment throughout the day. Our district additionally employs two full time night custodians who are responsible for cleaning all facilities daily. All state and district guidelines governing the custodian tasks have been implemented and are followed in accordance with all applicable laws. Improvements: Cunningham School was modernized between 2011 & 2013 which included many campus wide upgrades as well as interior remodel of approximately 20 classrooms and student restrooms. In 2019 the site received new fencing along the front of the school to enhance safety and security as well as create a single point of entry. Maintenance improvement projects continue to be done on this campus, including concrete, asphalt, and landscaping. Cunningham school is in very good condition considering its age. Adequacy: The Turlock Unified School District prides itself in offering clean, safe, and adequate school facilities. Our buildings offer adequate heat and air and are maintained in accordance with stringent state and district guidelines. FIT Results: The FIT form dated October 2023 may list some items found during the site inspection. These items should not be confused as 'Non-functioning' or affect the overall statement of the school site that it is 'clean, safe and functional.' Work orders are input on a regular basis and are usually addressed within a two-week period.

There are many opportunities for parent involvement to help us maintain a positive, productive and safe learning environment for every student.

Cunningham Elementary School offers a variety of activities including Reading and Math Literacy Nights, Cookies with Santa, Science Night and other events. Parents also participate in: Open House, Family Academic Nights, School Site Council, English Language Advisory Council, Coffee with the Principal, Principal Meetings, Back to School Night, Golden Eagle Awards, student performances, student study trips, School Safety Committee and as classroom volunteers. PIQE will be offered to support parent learning. To further support parent education, English as a Second Language classes are offered through our adult school. Our school counselor and clinician offer parent support and education through meetings, phone calls, and webinars.

Our community liaisons and site administrators are available for walk-in meetings and appointments, and all communications are offered in both English and Spanish.

Our site solicits parent input through surveys shared related to student and school site needs. Site administration utilizes BB Comms to share out school information via phone call, text message, and email. Classroom teachers utilize communication applications (e.g., ParentSquare, Class Dojo, Remind, etc.) to connect with families regularly. Site administrators and staff are readily available before school and after school to connect with families in person to discuss student needs as well as suggestions for site improvements. The school's community liaisons works with school community members and our Family Resource Center (e.g., parents, grandparents, guardians) to identify specific needs and to connect them with resources from our site counselor, clinician, and community resources. Fiscal Year 2022-23 Types of Services Funded

Cunningham School offers a variety of programs and services to support students in order to increase student achievement, enrich their educational experiences through lessons that incorporate agriculture science, and prepare them for their college and career plans. In addition, Cunningham Elementary has a Gifted and Talented program for students in grades fourth through sixth grades.

Cunningham not only provides enriching educational opportunities for all students, but each grade level also offers both an intervention block and English Language Development groups to ensure students receive instructional support according to their needs. With the assistance of site support staff, teachers are able to meet with small groups of students in order to implement intense intervention strategies. Cunningham staff and students are also supported by a District funded Early Literacy Instructional teacher who services scholars in need of extra foundational reading skills in grades 1-2 grades, and we have two Cunningham's Reading Specialist who provide supplemental reading support to students in grades 3-6. We also have a full-time mathematics intervention coach servicing 3-6 grade scholars. Students identified as English learners in grades 3-6 receive supplemental designated ELD support from our site's part-time EL Paraprofessional and our ELD Newcomers receive additional support from our part-time ELD specialist. Other opportunities that are available to students who are below grade level include use of online educational applications to support specific academic and language needs (e.g., Lexia English, Reflex Math). We have partnerships with Jessica's House and mentoring with CSUS, the CSUS Jr. Scientist Program, Running Club, classroom music for TK-4, and scholars in grades 5th and 6th participate in orchestra, band, or choir. The After School Education Program (ASES) provides eighty-six Cunningham students with tutoring and enrichment opportunities, and Expanded Learning Opportunity Program for kindergartners will begin in January 2024.

Professional Development

Professional Development

The Turlock Unified School District Local Control Accountability Plan prioritized district-wide professional development opportunities for TK-12 to include subject matter, English language development, technology, best practices, equity, and social emotional learning. Multiple measures including CAASPP results, ELPAC achievement data, common formative assessments, and data from site walk through/educational rounds are utilized to prioritize needs. Additionally, TUSD's initiatives and staff input continue to drive the professional development offerings.

Staff is provided with weekly embedded collaboration time in addition to opportunities for extended collaboration outside of the school day. The collaboration time allows teachers to focus on the four essential questions of a PLC, 1.) What do we expect students to learn? 2.) How do we know if students have learned? 3.) What will we do if they don't learn it? 4.) What will we do if

they do learn it?

Year one and year two teachers are enrolled in TUSD's Induction Program which is in the fifth year of implementation. The Induction Program activities are based on the California Standards for the Teaching Profession which outlines the numerous interconnected skills that comprise the professional practices of teaching.

Professional development and support is provided in the following areas: Professional Learning Communities; Math Instruction; ELA/ELD Instruction; Advanced Placement; Technology; Small Group Instruction; Social Emotional Learning, Biliteracy, and Next Generation Science Standards. Professional development opportunities occur during a combination of the regular school day, after hours, and during the summer. TUSD has reading and math intervention teachers at all nine elementary sites to accelerate student learning.

There are several formal Special Education administrative, teacher, and parent trainings scheduled each year that include the following topics: Service delivery for special education students with various handicapping conditions, the referral process for students with special education needs, how to accurately complete the IEP documents, how to maintain legally defensible reports/IEP documents/meetings, behavioral tools/strategies for district staff, case law and disability awareness. At sites, training specific to the students and programs at each site occurs throughout the school year.
