# SYRACUSE UNIVERSITY OFFICE OF ACADEMIC AFFAIRS TUITION CREDIT POLICY FOR OUTSIDE AGENCIES

#### ELIGIBILITY:

Outside Agencies that have been granted remitted tuition credits may use these credits solely for current employees of the agency, subject to the restrictions noted in this policy. The agency is responsible for submitting a completed Usage Approval Form to the Remitted Tuition Coordinator in the Office of the Bursar no later than the last day of late registration.

#### CONDITIONS:

- Tuition credit hours are available for use within four semesters following the semester of placement completion. The two summer sessions count as one semester. The credits may not be applied retroactively to prior tuition charges. Tuition credit is forfeited if not used before or during the semester of expiration, and the semester of expiration will not be altered under any circumstances.
- The maximum number of credits which the University will award for supervision performed by any one field instructor in a semester is six.
- The sale and/or purchase of tuition credits is expressly forbidden. If it is determined that credits have been obtained in this manner, the credits will become null and void.

#### USE:

Tuition credits MAY be applied to:

 On campus undergraduate and graduate courses offered by main campus colleges, University College, and the extended campus of the School of Education, whether taken for credit or audited.

#### RESTRICTIONS:

- Tuition for a full time undergraduate student except with the advance and express approval of the Office of Financial Aid and Scholarship Programs.
- Tuition for courses offered by SUNY College of Environmental Science and Forestry and SUNY Upstate Medical Center, even if the student registers for them through an SU school or college (i.e. Central NY Masters in Public Health Program).
- Fees other than tuition, such as the student activity fee, lab fees, fees for course materials, health service fees and athletic fees.
- Tuition for online programs including MBA@Syracuse, Communications@Syracuse, or other online programs.

Syracuse University reserves the right restrict acceptance of tuition credit for courses, programs, and workshops including non-credit Informal and Professional Development courses offered by University College. Tuition credit is not accepted for programs where the charge covers expenses other than tuition. Any questions about eligibility should be addressed to the Office of Financial Aid and Scholarship Programs.

The policy for reinstatement of tuition credit on dropped courses is the same as for students paying their own tuition, as explained in the *Syracuse University Tuition, Fees and Related Policy* publication. If the student drops regular courses during the first three weeks of class (or during the first week of a summer session) credits will be restored. For non-credit courses, tuition credit hours will be reinstated only if the class is dropped prior to the second meeting.

Syracuse University reserves the right to modify this policy at its discretion.

#### AGENCY AGREEMENT

This Agency Agreement (this "Agreement") sets forth the agreement between SYRACUSE UNIVERSITY, a not-for profit educational corporation, existing under the laws of the State of New York with its principal campus and office in Syracuse, New York acting in behalf of its Falk College of Sport and Human Dynamics' academic programs (the "University"), and Sauquoit Valley Central School District a corporation existing under the laws of the New York, with its principal office located at 2601 Oneida Street, Sauquoit, NY 13456 (the "Agency"), relating to field work by the University students at the Agency and tuition credits at the University granted to the Agency in recognition of such field work.

#### 1. Term.

Except as set forth herein, this Agreement will be in force for a period of not more than five years beginning 4/18/2024 after which a new agreement may be negotiated.

- Agency Obligations.
- (a) The Agency will allow a mutually agreed upon number of University students to engage in field work at the facilities of the Agency for a mutually agreed upon number of hours and days during an academic period.
- (b) The Agency shall designate in writing one or more of its employees to supervise the University's students at the Agency (each, a "Representative"). The Representative shall be in charge of all programs conducted in accordance with this Agreement. The University may require certification of this designation on an appropriate form that sets forth pertinent qualifications of the employees as requested by the University. The University may reject any employee whose qualifications it deems insufficient.
- (c) Supervision of the University's students at the Agency shall be furnished by the Agency. Agency personnel who supervise University students shall furnish written evaluations of the students no later than the last day of class of each semester. Any changes of placement within the Agency and/or supervisor must be sent in writing to Falk College immediately in order to qualify for tuition credits.
- (d) The Agency shall promptly notify the University upon the discovery of any exposure of University students or employees to health hazards at the Agency. In the event of accident or illness, the Agency shall, if it has the facilities to do so, render emergency care to students and employees of the University. The cost of emergency care will be paid by the student or employee.

- 3. University Obligations.
- (a) A representative of the University's academic department specified above shall assure to the Agency that a student will be in acceptable academic standing to be engaged in field work at the Agency, and shall provide other student information reasonably required by the Agency.
- (b) The University shall remove any employee or student of the University from field work at the Agency upon written notice that such person is no longer acceptable to the Agency.
- (c) The University shall grant to the Agency tuition credits in accordance with the procedures set forth in the University's policy statement entitled "Tuition Credit Policy for Outside Agencies," to be attached to and made part to this agreement. These tuition credits will be granted for supervision of student field experiences, which are approved for such benefits the formula by which the University shall grant to the Agency tuition credits is:

One-half (1/2) a tuition credit hour for 37 clock hours worked by a student in the Agency. Such benefits may be used by employees of the Agency designated by the Agency, all in accordance with the attached policy statement.

# 4. Mutual Obligations.

- (a) The University shall furnish all orientation of Agency personnel, and the Agency shall furnish all orientation of University personnel and students, necessary or desirable for making the program of field work, supervision, and instruction as successful as possible.
- (b) It is mutually agreed that at no time shall either party discriminate against any employee or student for employment, field work, or registration in the course of study because of race, color, creed, sex, age, marital status, sexual orientation, religion, disability, or national origin.
- (c) The University will defend the Agency with competent counsel, hold it harmless and indemnify the Agency from any liability, actions, damages, or claims brought against the Agency as the result of (i) the negligent acts or omissions of the University or its employees, or (ii) a breach of this Agreement or any representation herein. The Agency will defend the University with competent counsel, hold it harmless and indemnify the University from any liability, actions, damages, or claims brought against the University as the result of (i) the negligent acts or omissions of the Agency or its employees, or (ii) a breach of this Agreement or any representation herein. The University and the Agency respectively, shall maintain liability insurance, in amounts reasonably satisfactory to the other party, covering the acts or omission of the respective employees and contractual liability created in this section.
- (d) In the course of the activities contemplated by this Agreement, the University and the Agency may exchange information that is identified (orally or in writing) as confidential or is of such a nature that a reasonable person would understand such information to be confidential ("Confidential Information"); provided that "Confidential Information" shall not include information (i) generally known to the public, (ii) already known, through legal means, to the institution receiving the information, or (iii) legally obtained from a third party. Confidential Information shall be deemed to include the non-public personal financial information, student education records, and other protected information relating to students in accordance with the Gramm-Leach Bliley Act (and the Federal Trade Commission's implementing regulations) and the Family Education Rights and Privacy Act of 1974. Each party agrees to use the other party's Confidential Information solely for the purpose of the activities contemplated by this Agreement, and not to disclose such Confidential Information to any person or entity other than its own trustees, officers, employees, agents, advisors and representatives

who have a reasonable need to know the information for purposes of fulfilling their obligations herein. In the event that either party is required to disclose the other party's Confidential Information pursuant to applicable law or a judicial or government order, or seeks to disclose Confidential Information in connection with any litigation, alternative dispute resolution proceeding or regulatory proceeding, it may make such disclosure, but will notify the other party in advance, so as to allow the other party an opportunity to obtain a protective order or similar relief.

#### 5. Breach and Termination.

This Agreement may be terminated as follows:

- (a) Either party may terminate this Agreement upon 30 days' prior written notice for any reason or no reason.
- (b) Either party may terminate this Agreement immediately if it determines, in its sole discretion, that the health, safety or welfare of any student or employee is in danger.

Except to the extent (i) required by law or the Middle States Commission, or (ii) necessary to ensure the safety and wellbeing of participating students, termination of this Agreement shall not affect students already engaged in field work at the time the notice of termination is given, who shall be allowed to complete the fieldwork.

#### Miscellaneous.

- (a) Force Majeure. Neither party shall be liable for failure to perform any duty or obligation under this Agreement, if such failure is occasioned by any act of God, fire, labor dispute, inevitable accident, war, terrorist attack (or threat thereof), or any other cause outside the reasonable control of the party that had the duty to perform; provided, however, that the non-performing party shall resume performance in accordance with the otherwise applicable terms and conditions of this Agreement as soon as practicable following abatement of such cause.
- (b) Independent Contractors. The University and the Agency shall be independent contractors and not partners, joint venturers, principal and agent, or any other similar relationship. Neither party shall have, or hold itself out as having, the power or authority to bind or create liability for the other by its negligent or intentional act or omission.
- (c) Notices. Any notice required under this Agreement shall be in writing and in the English language, and shall be given to the following addresses by personal delivery or overnight delivery service and effective on the date received or denied, or by first class mail and deemed effective three days after sending:

Either party may change its designee or address for notices from time to time in accordance with this section.

- (d) Entire Agreement. This Agreement represents the entire understanding of the parties with respect to its subject matter, and it supersedes all prior agreements, understandings or representations, whether oral or written, by either institution. No amendment or modification of this Agreement shall be valid or enforceable unless made in writing and signed by the parties.
- (e) Waiver. A waiver of any provision or breach of this Agreement must be in writing and signed by the party making the waiver in order to be effective and binding. The waiver of any breach of this Agreement by either party shall not operate or be construed as a waiver of any subsequent breach. The waiver of any term or condition of this Agreement by either party shall not operate or be construed as a waiver of any other term or condition.
- (f) Assignment; Binding Effect. This Agreement may not be assigned by either party without the prior written consent of the other, and any purported assignment without such consent shall be void. Subject to the preceding sentence, this Agreement shall be binding upon and shall benefit both parties and their respective successors and assigns.

- (g) Applicable Law; Jurisdiction; Venue. This Agreement shall be governed by, and construed and enforced in accordance with, the laws of New York State, without regard to principles of conflicts of law. The venue of any proceeding to resolve a dispute with respect to this Agreement shall be a state or federal court with appropriate subject matter jurisdiction located in Onondaga County, New York, USA, and both institutions hereby submit to the jurisdiction of such court.
- (h) Severability. If any provision of this Agreement is held by a court of competent jurisdiction to be illegal or unenforceable, the remaining provisions of this Agreement shall not be affected, and the rights and obligations of the parties shall be construed and enforced as if the Agreement did not contain the particular provision held to be invalid, unless to do so would contravene the present valid and legal intent of the parties.
- (i) <u>Counterparts</u>. This Agreement may be executed in two or more counterparts, each of which shall be an original but all of which shall constitute one and the same instrument.
