If there are multiple children in a family for Red Bank Charter School students, the rate is reduced by \$25.00 per child for the Summer Institute Program.

*Available only to those children who participate in our Summer Institute Program.

For our families who qualify for reduced lunch, the fee is \$100.00 per child and for families who qualify for free lunch, a fee of \$50.00 per child is required for the Summer Institute Program.
