



Educational Highlights of 2022-2023

- Prioritized grant funding to provide preventative and intervention mental health supports for students and staff.
- Launched free, full-day Pre-K program at FMB school.
- Offered after school enrichment camps.
- Offered academic summer program for struggling students.
- Scored in top 30% or better in the county in Math on NJSLA, scoring in first place in grades 4 and 7 and in second place in grade 8.
- Scored in the top ¼ in the county for grade 8 NJSLA in science which includes the grades 6-8 band of standards

Educational Highlights of 2022-2023

- Scored in top 50% in the county in 4 of 6 tested grades for ELA
- Began training staff on the latest Danielson teacher evaluation rubric.
- Organized school/community building events to include Hour of Code, guest speakers/assembly, and One School/One Book.
- Vertical articulation between 8th grade teachers and Newton High School in all major content areas (LA, Math, SS, Science).

- Maintain current instructional programs and class sizes
- Replace aging technology as needed

- Support quality teacher/staff professional development
- Maintain school building facilities

ARSD Instructional Goals 2023-2024

- ARSD will continue its use of student data points to guide instruction and intervention.


