

Pursuant to due call and notice thereof, a Regular meeting of the School Board of Independent School District No. 2170 (Staples Motley), State of Minnesota, was duly held in said school district on April 19th 2021, at 6:00 o'clock pm for the purpose, in part, of canvassing a special election.

Member Bryan Winkels moved the adoption of the following resolution:

**RESOLUTION CANVASSING RETURNS
OF VOTES OF SCHOOL DISTRICT SPECIAL ELECTION**

BE IT RESOLVED by the School Board of Independent School District No. 2170, State of Minnesota, as follows:

1. It is hereby found, determined and declared that the special election of the voters of this school district held on April 13, 2021, was in all respects duly and legally called and held.
2. As specified in the attached Abstract and Return of Votes Cast, at said election a total of 2467 voters of the school district voted on the question of authorizing the issuance of school building bonds for a school acquisition and betterment program (SCHOOL DISTRICT QUESTION 1), of which 909 voted in favor, 1555 voted against the same, and there were 3 completely blank or defective ballots related to this question. Said proposition, having (not) received the approval of at least a majority of such votes, is hereby declared to have **Failed**.
3. The clerk is hereby directed to certify the results of the election to the county auditors of each county in which the school district is located in whole or in part and to the Commissioner of Education.

The motion for the adoption of the foregoing resolution was duly seconded by Member Lisa Anderson, and upon vote being taken thereon, the following voted in favor thereof:
