\$400 Tax Credit

All residents of Arizona can participate in the Tax Credit. You don't have to have a student currently enrolled at KMS. Your donations are so helpful to provide supplemental classroom materials, activity bus to allow students to participate in after school activities.

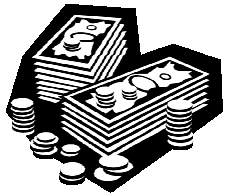
The Tax Credit is simple!

Taxpayers may **donate** as much as **\$400** to a public school and **qualify for a state tax credit.** (A.R.S. SB 1529)

You can take up to **\$400** off your **state tax bill** or receive an additional **refund** of up to **\$400.** In addition, your contribution is **deductible from federal income tax** as a charitable contribution. *

*You now have until **April 15, 2017** to make a tax credit donation to a school or student activity of your choice.*

Does this sound too good to be true? Believe it, it is true!



This is a great way for schools to raise much needed funds.

Please complete the form on the back of this brochure and mail it, with your check, to Kyrene Middle School. You may also return the form in person to the KMS office. You will be provided a receipt in the mail for your tax records.

- You **do not** need to have a child enrolled at **Kyrene Middle School** for your donation to be eligible for the state tax credit. So pass this information on to your neighbors, relatives & friends.
- The state tax credit allows you to **reduce the amount of your tax bill** to the state or to **increase your refund** from the state.
- The **\$400** maximum state tax credit is available for taxpayers who are married and file jointly. Those taxpayers that are married and filing separately each qualify for a credit of **\$200** on the separate returns. The credit is limited to **\$200** for single taxpayers or heads of household.
- You may **donate to more than one** public school. However, the maximum state tax credit is \$400. For example, you could donate \$200 to Kyrene Middle School and \$200 to a Kyrene Elementary School for a total of \$400.
- You may **donate less than your allowable limit.** Your state tax credit would be equal to the amount of your donation. If you donate \$100, your state tax credit would be \$100.

Check with your company to see if they offer **employee matching grants.** If you work for a company that has these matching grants and donate up to \$400 to the school, your employer may **match your \$400 donation.** This gives the school a total donation of **up to \$800.** Your employer should have the forms for the grant matching program.
