SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

- ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. 1. **In the space provided below, please describe how the LEA meaningfully engaged a diverse and representative set of the applicable stakeholders in developing a plan to use these funds and implementing that plan.**

CACPCS conducted focus groups and small group meetings with school leadership and operations staff, teacher leaders, parents and students to get input on both the ESSER II and ARP spending plans. The school's full board, Finance Committee and senior executives at Children's Aid (CACPCS institutional partner) were all consulted during meetings throughout the development of this proposed spending plan. Additionally, a family survey conducted in the late Spring of 2021 provided the Head of School and Principals with valuable feedback. For example, overwhelmingly parents and caregivers indicated more opportunities for after school and summer academic support as a strategy to address potential learning loss, so the CACPCS spending plan reflects a several year investment in those supports. Students wanted more opportunities for fun and engaging experiences and better technology devices. Operating safely in the face of COVID-19 was also a priority for staff, leadership and parents/caregivers so the plan reflects changing furniture in the lower grades to make physical distancing possible while allowing all of our students to return. Parents also wanted to see the option for remote learning continue and given the school's plans to offer remote learning if there are classroom closures, continued investments in technology are also evident in this spending plan.

CACPCS will continue to engage stakeholders throughout implementation through surveys twice a year of staff and parents and student focus groups at the mid-year point of the year (February). Additionally, the school convenes a weekly parent meeting via Zoom which provides the school's leadership with regular feedback on issues and input on programs and other supports for students. Finally, families and students participating in our after school and summer tutoring and enrichment programs will complete surveys to inform programming for the upcoming year or the upcoming cycle as well.

3. **In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.**

Removed furniture from all of our K-2 classrooms that didn't allow students to sit in one direction with at least 3 feet of physical distance. So tables were replaced by individual desks.

CACPCS has also contracted with cleaning vendors to provide additional daily classroom cleaning and disinfecting.

CACPCS has included additional resources for substitute teachers to step in to teach when a teacher cannot come to school because they are sick or are having any symptoms included on the daily staff health screen.

CACPCS is investing in ventilation upgrades in several classrooms and office spaces at its middle school location.

CACPCS has continued to invest in its wifi infrastructure and computer devices in both locations to eliminate the need for larger group meetings in-person while in school. These meetings can happen online supported by strong wifi access and computer devices.

4. **In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

Based on baseline assessment data at the beginning of the school year, the academic team identifies all Tier III scholars. The Fountas and Pinnell (F&P) Assessment is conducted quarterly at a minimum for Grades K-6 and for certain students with additional needs in Grades 7-8. Observations are conducted in the classroom by members of the academic team. Classroom teachers provide additional information to obtain a range of data points for the scholars. Students who obtained reading intervention previously and students with IEP's that are identified as Tier III students are prioritized on the list of students the Interventionist will serve.

Students are re-tiered on a quarterly basis using F&P levels to determine if students will continue receiving intervention, if additional pull out/push in reading intervention is needed or if that support will be phased out based on their progress.

CACPCS will also utilize results from ANet ELA and Math interim assessments for Grades 2-8, the Principals and Academic Deans will conduct item analyses using ANet's data review protocols to continue to support teachers in their daily lesson planning. In grades 6-8, there will be a particular focus on the consistent implementation and review of formative (weekly) and summative assessments at the end of units of study. These frequent reviews will further drive instruction and content/skills mastery while reinforcing teachers' understanding of power and supporting standards.

With the support of ANet, Sped Collaborative and Children's Aid, CACPCS's instructional leadership use the following types of data to determine if CACPCS is building a rigorous K-8 learning continuum that is addressing the academic impact of lost instructional time on all of its students as well as its special populations.

- Unit assessment data
- Reading level data
- Interim assessment data
- Coaching and classroom observation data

Classroom-level and school-level progress monitoring focuses on ensuring students are meeting or exceeding academic benchmarks while bi-monthly data review meetings at the Curriculum Team level encourages the identification of larger trends across all grades and certain populations like our ELLs that school leadership should be working to support further.

Based on feedback from students, parents, and staff, CACPCS's ARP spending plan focuses resources on the following investments in a robust, relevant comprehensive out-of-school time approach including before-school, after-school, summer, and holiday programming to address unfinished learning created by the COVID-19 crisis and to create additional enrichment opportunities.

Although the majority of the allocated ARP funding will be spent on addressing learning loss over the next 2-3 years, the remaining funds will be spent on ventilation improvements, cleaning services and removing furniture that does not allow sufficient physical distancing in classrooms, and student gift cards.

Student gift cards for class and individual incentives. Student gift cards for class and individual incentives to acknowledge students' successes in order to encourage prosocial and positive academic behaviors. Gift cards will be provided to students of the month who model the school's values of Courage, Achievement, Compassion, Perseverance, Curiosity and Service. Since CACPCS's approach to education is holistic, the academic, social and emotional are all acknowledged and celebrated. The gift cards will allow scholars who model these values and their related behaviors an opportunity to purchase books, school supplies, etc.

These gift cards will also provide incentives for attendance improvements of students supported by Success Mentors due to chronic absence caused by homelessness or other challenges their families may be experiencing as a result of COVID-19 or its aftermath.

CACPCS will seek feedback and input from parents during the weekly/bi-weekly Zoom parent meetings and via surveys distributed periodically throughout the year as feedback on policies affecting the plan need to change and/or aspects of the plans are implemented. CACPCS will also host a series of parent meetings in the Spring of each year to collect feedback on the current year's plans and to seek input (including potential changes) to any planning for the upcoming year.
