### SCHOOL PROFILE

The Hacienda La Puente Unified School District is the largest school district in the San Gabriel Valley, serving approximately 80,000 students; 20,000 pre-K-12 and 30,000 adult education students at two main facilities and 32 satellite sites. The District also has the largest correctional education program in the nation, serving an additional 33,000 students at eight correctional facilities throughout Los Angeles County. The 11.5 square mile District serves the diverse communities of City of Industry, Hacienda Heights, La Puente and portions of Valinda and West Covina. The District includes 16 elementary schools, six K-8 schools, four middle schools, four comprehensive high schools, one alternative high school, an orthopedic unit for the physically handicapped, and an extensive child development and adult education program. The District also maintains an Administration Center, an Instructional Services Center, a Multilingual Assessment Center, a Professional Library, and a Curriculum Lab.

## SCHOOL STATEMENTS

### School Mission:

We at Los Molinos School believe that all students come with a desire for learning and a belief that all things are possible. We foster critical thinking through diverse opportunities, shared decision making, and mutual respect. We prepare our students for the future through rigorous curriculum with the goal of promoting lifelong learning. School Goals

At Los Molinos, teachers and staff are committed to ensuring academic success for all students within a professional learning community. This is accomplished through ongoing student data analysis and collaborative planning. Teachers routinely use annual state assessment data, district interim results, and grade-level common assessments to inform instructional planning. Los Molinos teachers are trained to use technology-based data management systems, student assessment software, and web-based instructional programs to support student learning. We believe that students are most successful in a positive environment. Students are motivated when given recognition for their accomplishments and efforts. We recognize students for their academic achievements at each trimester with an awards ceremony. Students receive awards for Reading, English Language Arts, Math, and Writing. Parents are encouraged to attend the award ceremonies. In addition to an emphasis on academic achievement, Los Molinos strives to instill social and character values among our children. One way of achieving this goal is through providing opportunities for students, staff, and parents to learn and reflect on civil responsibility, patriotism, and national history. Developing a strong sense of character is accomplished by regularly acknowledging students who demonstrate positive behaviors that are in line with character building tenets. We focus on three rules at Los Molinos: Be Safe, Respectful and Responsible. Students earn "Way to go Wildcat" tickets for making positive choices at school and then are entered in a weekly drawing. We also select a Wildcat of the Week, someone who exemplifies the character-based Word of the Month. Finally, Los Molinos is proud to provide enrichment opportunities to our students. We integrate STEAM (Science, Technology, Engineering, Arts, and Mathematics) into daily lessons as well as afterschool classes. Students can participate in Lego Engineering, Chess Club, Art classes, Beginning Band, Mad Science and much more.

### Principal's Message:

Los Molinos prides itself in creating 21st century classrooms, where all students prepare for College and Career Readiness. Our staff is dedicated to the pursuit of excellence in education for ALL students by practicing research based instruction. Our curriculum ensures academic rigor, creativity, and critical thinking. Students are also taught to be valued members of a community as we instill Character enhancing traits such as Respect, Responsibility and Integrity into our curriculum. Our goals for the school year include:

- Creating a positive school climate utilizing Positive Behavior Support and an atmosphere of caring and trust.
- Emphasizing the 4 C's: Creativity, Critical Thinking, Collaboration, and Communication.
- Integration of Technology across all content areas.
- Implementation of research based intervention programs in both ELA and Math. Los Molinos firmly believes in the creation of a Partnership with Parents and our Community. We encourage parents to volunteer at the school and home by becoming members of our Parent Teacher Association (PTA), School Site Council (SSC), English Language Advisory Council (ELAC), or helping in the classroom. At Los Molinos, parents take an active part in their child's education which is evident in the success of our programs and family events. Lastly, Los Molinos teachers work diligently in their weekly Professional Learning Collaborative teams to create a comprehensive academic and social experience for each student. It is through this collaborative effort that we continue to offer rigorous, data driven instruction, focused support and enrichment programs, and set the foundation for students who are "life-long" learners.

**SCHOOL FACILITIES**

Los Molinos Elementary School provides a safe, clean environment for students, staff, and volunteers. The school is situated on 9.9 acres. School facilities were built in 1963, and span more than 34,350 square feet. The school serves students in 22 regular classrooms, two portable classrooms, a library, two state of the art computer labs, a cafeteria/multipurpose room with full stage and an academic resource room.

**Cleaning Process and Schedule**

The District has adopted cleaning standards for all schools in the District. A summary of these standards is available at the school office or at the District office. The site administration team works with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

**Maintenance and Repair**

A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

## INSTRUCTIONAL MATERIALS

Hacienda La Puente Unified School District sets a high priority upon ensuring that sufficient and current textbooks and materials are available to support the school's instructional program. Hacienda La Puente Unified School District held a Public Hearing on September 14, 2023, and determined that each school within the District has sufficient and good quality textbooks, instructional materials, or science lab equipment, pursuant to the settlement of Williams vs. the State of California. All textbooks and instructional materials used within the District are aligned with the Common Core State Standards.

All students, including English Learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects and foreign languages for use in the classroom and to take home. Instructional materials for grades K-8 are selected from the State's most recent list of standards-based materials; for grades 9-12, all materials have been approved by the Board of Education.

Hacienda La Puente Unified School District follows the State Board of Education's six-year adoption cycle for core content materials and the eight-year cycle for textbook adoptions in foreign language and visual and performing arts. District textbook review and adoption activities occur the year following the State's adoption.

#### PHYSICAL FITNESS ASSESSMENT

In the spring of each year, all California schools are required by the state to administer a physical fitness test to students in the fifth, seventh, and ninth grades. The physical fitness test is a standardized evaluation that measures each student's ability to perform fitness tasks in five major areas. The five major areas are Aerobic Capacity, Abdominal Strength and Endurance, Extensor and Strength and Flexibility, Upper Body Strength and Endurance, and Flexibility.

### SCHOOL SAFETY

The safety of students and staff is a primary concern of all Hacienda La Puente Unified schools and staff. All visitors to the campus must sign in at the school office and wear a visitor's pass at all times. Supervision is provided to ensure the safety of each student before school, during breaks, at lunch, and after school. Supervision is a responsibility shared among volunteers, teachers, and administrators.

The school is always in compliance with the laws, rules, and regulations pertaining to hazardous materials and state earthquake standards. Safety drills, including fire, earthquake, and lock-down, are held on a rotating basis throughout the year.

To further safeguard the well-being of students and staff, a comprehensive School Site Safety Plan has been developed by the School Site Council. The Safety Plan is annually updated in the fall; the last review was performed in September, 2023. An updated copy of the plan is available to the public at the school and District offices. Any revisions and updates are reviewed immediately with the staff. Key elements of the Safety Plan focus on the following:

- School rules and procedures
- Disaster procedures/routine and emergency drills
- Current status of school crime
- Notification to teachers
- Child abuse reporting procedures
- School-wide dress code
- Policies related to suspension/expulsion
- Sexual harassment policy
- Safe ingress and egress of pupils, parents/guardians, and school employees

During the COVID-19 pandemic, protecting the health and safety of our staff, students and families is a priority. Hacienda La Puente Unified has created comprehensive health and safety protocols which include: cleaning, disinfecting and sanitizing, use of personal protective equipment, symptom screening, social distancing, hygiene practices, testing, and responding to positive cases.
