## School Facility Conditions and Planned Improvements

**General:** The district places a strong emphasis on ensuring that all schools are safe, clean, environmentally friendly, mechanically functional and inviting for students, staff members, and the community. To assist in this effort, the district utilizes the Facility Inspection Tool (FIT) developed by the State of California OPSC and local operations department developed inspection survey methods to keep facilities in compliance with all federal and state health and safety regulations. The district regularly inspects and reviews the condition of the school facilities and surrounding grounds. The district places the highest priority on those safeguards that impact the fire, life and safety protection of the students, staff, and school buildings. Below is more specific information on the condition of the school and the efforts made to ensure that students are provided with a clean, safe, and functional learning environment.

**Age of School Buildings:** Eldridge was constructed in 1956. This school has thirty-two (32) regular classrooms, a multipurpose room, a library, and an administration building. In addition to the main building, there are thirteen (13) portable classrooms that have been added to accommodate class size reduction and instructional programs for the Alameda County Office of Education.

**Maintenance and Repair:** District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order system process is used to ensure efficient service and highest priority is given to emergency repairs. At the time of publication, 100% of the school's restrooms on campus were in good working order.

**Cleaning Process and Schedule:** The district has developed cleaning standards and schedules for all schools in the district. A summary of these standards and schedules is available at the school or the Maintenance & Operations office. The principal, with the guidance of the Facilities, Maintenance, Operations and Transportation (FMOT) Department works daily with the custodial team to ensure that the cleaning standards are met, and that classrooms, restrooms, and campus grounds are kept clean, safe, and well-maintained.

**Modernization Projects:** Since 2019, local bond funds (Measure H) are being used to complete various modernization and infrastructures projects throughout HUSD. At Eldridge Elementary these projects have included replacement of the roof system and exterior painting of the school. All work described was completed by the end of the 2020 summer period.

## Fiscal Year 2022-23 Types of Services Funded

Eldridge is a Title I school which receives state and federal funding to support our students. Our students receive free breakfast and lunch during the school day.

To help serve and support our community, Eldridge has a Community Support Specialist and a Family Engagement Specialist who work closely with families and the community to bring in resources, host special events, and facilitate education classes for families. Eldridge also has a full time counselor to help support the socio-emotional needs of our students. Eldridge Elementary provides after school interventions for our students in ELA and Math (certificated teachers), as well as our Classified paraprofessional provides ELA intervention during the school day for those students that may need Tier2 and Tier 3 supports.

Youth Enrichment Program (YEP) offers before school and after school programming at Eldridge. YEP gives students opportunities for homework/academic support and to expand their learning through fun recreational, athletic, and educational activities. Students grow socially, emotionally and physically, build community and belonging, develop confidence and resilience, and have fun in a safe supportive environment.

## Professional Development

This section provides information on the annual number of school days dedicated to staff development for the most recent three-year period.

As part of the growth process, opportunities for training and staff development are provided at both the district and individual school sites to administrators, teachers, and classified staff. The school provided two full days of professional development on August 14 and 15, 2023. The district offered an additional staff development day in December for a total of 3 staff development days in 23/24. The curricular focus of the current school year is ELA with a focus on small group instruction and culturally relevant literature. In addition, Hayward Unified School District is also coordinating minimum days to provide ongoing professional development.

The transition to Common Core Mathematics/ELA teaching and learning is supported by administration, instructional coaches, and grade level teams.

We've also focused on Equity and Deeper Learning in order to engage our students and support them to develop critical thinking skills. Another important focus is Culturally Responsive Teaching. Our staff is currently being trained to better understand and serve the many different cultures that are part of our community. CRT is at the core of what we do at Eldridge.
