

MINUTES OF THE SPECIAL MEETING HELD ON AUGUST 4, 2022

The special meeting of the Freeport Area School District Board of School Directors scheduled for 7:30 pm in the Audion of the Freeport Area High School, 625 South Pike Road, Sarver, Pennsylvania, was called to order by Mr. Adam M. Toncini, President, at 7:55 p.m.
