Tax Rate Considerations



Ballot Language

Legislation passed in 2019 requires "THIS IS A PROPERTY TAX INCREASE" to appear on the ballot.

The language is required to inform the voter that the term of repayment will be extended.

It is required even when the tax rate will remain the same.



Bonding Capacity Impact

Every half penny = \$5M increase in bonding capacity

\$282,400,000	\$145,400,000	\$137,000,000	\$0.341	\$0.005	(half-penny)

Taxpayer Impact

For every \$100,000 in home value the half-penny increases tax owed by \$5.00. That is an <u>annual</u> increase.

Home Value	\$200,000.00	\$300,000.00	\$400,000.00	\$500,000.00
\$0.005	\$5.00	\$10.00	\$15.00	\$20.00
\$0.010	\$10.00	\$20.00	\$30.00	\$40.00

Value of Home PRIOR to applying \$100,000 State Mandatory Homestead Exemption. Tax Impacts calculated after reducing home values by \$100,000.
