Ms. Slade apologized she missed the meeting. Mrs. Tonkin reported the meeting was successful and the committee determined there is not a need to have a monthly meeting. Discipline is happening and has improved. If there is a need to meet, the committee will be contacted.

Budget Committee

Mr. Salov reported a meeting is scheduled and Ms. Slade has asked for a meeting invite be sent through Outlook.

Mrs. Tonkin thanked Mr. Roach for giving the standards for his field trip request.

Mr. Salov reported that on Tuesday, he and Mrs. Tonkin will be attending the PSBA Legislative meeting as voting delegates.

Ms. Slade thanked Ms. Woods for attending tonight's meeting and reported a fundraiser for the crime watch program. Ms. Woods has fliers for this fundraiser. This fundraiser also goes toward rewards to find criminals.

Ms. Slade questioned the 50/50 games of chance to raise money for athletics. Attorney Champion said this will be discussed at a later time.

Ms. Slade also shared her experience and pride to watch Jordan Hill play, who is an alumni from Steelton-Highspire, college graduate and went on to play for a professional football team.

Mr. Petrovich questioned the amount paid in services provided by TherAbilities. Dr. Castagneto answered TherAbilities is a contracted provider for physical therapy services and speech therapy. Dr. Castagneto is planning to do a cost analysis in January for these contracted services with other providers.

Dr. Castagneto reported the past week's activities. The Parent's Advisory Council dinner meeting had a good attendance, parents were updated on recent test scores, which have shown significantly increase from last year. There have been delays with information going out from PDE to the newspaper to publish, as a result of drops from last year's tests in neighboring districts'. A rush has been set for recalculations to be reported. Dr. Castagneto also reported at the Teachers' In-Service, teachers worked on developing data of students for effective teaching and effective learning.
