### **PRESENTATION**

Mr. Waters introduced Coach Binder for his request to the board for plans of a basketball tournament using district facilities. He is planning for four or five teams from the area, 3 days a week, for four to five weeks, from 5:00 to 8:00 p.m., for high school students ages 9-12. The teams consist of top twenty players, low key competition, helps to keep kids off the streets and to build team camaraderie. The charge per student is to cover the fees of certified referees, who have clearances; liability insurance, score keepers and all remaining funds will go into activity account to cover weekend shootouts. His staff plans to clean up and close up building, in order to save the expense of using facilities workers. All his staff members have clearances. Coach Binder announced Steelton-Highspire has been given the opportunity to play against York High in a game prior to a 76ers game in Philadelphia. The team will take a bus trip, will be given free tickets to watch the 76ers game and return the same day. No date has been set at this time, he will submit all forms for approval.

Mr. Waters introduced Mr. Frank Brown with Shared Growth. Mr. Brown acknowledged Coach Binder had coached him 35 years ago. He shared when he was age ten years old goofing around on the foul line Coach Binder disciplined him and that experience caused him to begin taking everything seriously, getting the opportunity to go to college.

Mr. Brown spoke to the board about a free mentoring program offered through the nonprofit organization. He works with ten African American male students beginning in ninth grade and following them until graduation, focusing on ten Habits of Mind. The program is designed to help students deal with handling multiple aspects including respect of teachers, authorities and relationships. Mr. Brown reported his first group of 17 students will graduate next week, 16 of these will graduate. The success rate is 2.5 GPA and 96% graduation rate. Mr. Spizzirri asked what he will need from the board to begin the program. Mr. Brown said he will need a list of ten students, dates for scheduling and grades of the students. He gave a handout for the software he will need for the program, available for free through a grant that tracks the student's grades and attendance. Mr. Waters explained permission slips will go out to the student's parents as with other programs. Coach Binder stated he also substitutes in the building and could help with the program. Mr. Brown reported the district selects the students for the program when Mr. Lewis questioned how a student would qualify for the program. Ms. Woods questioned the length of time to be spent with the students. Mr. Brown answered it's a personal commitment to the school for four years, to follow students through high school, he's planning on one day a month, possibly one period. Mr. Waters stated his interest for a motion to approve the program to be at the next meeting.
