Ms. Kagarise called the meeting to order at 6:30 P.M.

#### **ELECTION OF A TEMPORARY CHAIRPERSON**

Mr. Spizzirri made the motion for Mr. Derek Lewis to serve as Temporary Chairperson. Second by Mr. Salov. Ms. Slade made the motion to close nominations. Second by Mr. Lewis. Each person voted aye on roll call. (9 ayes, 0 nays, 0 abstention, 0 absent)

#### **ELECTION OF PRESIDENT**

Mr. Lewis called for nominations for the office of President. Mr. Spizzirri nominated Ms. Carricato for President. Second by Mr. Petrovich. Ms. Bowman nominated Ms. Slade for President. Second by Mr. Lewis. Mr. Lewis closed nominations for President. Natalie Bowman, Derek Lewis, Rachel Slade voted for Ms. Slade with three (3) votes. Mary Carricato, Janice Elliott, Samuel Petrovich, John Salov, Robert Spizzirri and Natasha Woods voted for Ms. Carricato with six (6) votes. Mr. Lewis announced Ms. Carricato as the Board President for 2015-2016.

#### **ELECTION OF VICE PRESIDENT**

Ms. Carricato called for nominations for the office of Vice President. Mr. Petrovich nominated Mr. Spizzirri for Vice President. Second by Ms. Elliott. Mr. Lewis nominated Ms. Slade for Vice President. Second by Ms. Bowman. Ms. Carricato closed the nominations for Vice President. Natalie Bowman, Derek Lewis, Rachel Slade and Natasha Woods voted for Ms. Slade with four (4) votes. Mary Carricato, Janice Elliott, Samuel Petrovich, John Salov, and Robert Spizzirri voted for Mr. Spizzirri with five (5) votes. Ms. Carricato announced Mr. Spizzirri as the Board Vice President for 2015-2016.
