We always strive to have students in the Least Restrictive Environment across all settings: transportation, related services, classroom and programs

Life is not self-contained

Special Education is a program; not a special education student

Students with IEPs don't have special needs; they have special rights

More services equals more restrictive

IEP Amendment

An amendment to an IEP is a minor change to the IEP during the year it is in place

Parent or team can request

Can be made with or without a meeting

Written document of the changes

Cannot be implemented until the parent signs; different than an annual

Does not change the annual meeting date

A substantive change is made through a formal IEP meeting

Evaluate Special Education Programs

Evaluate programs by the annual state report and any changes that need to be made

Observations of teachers and staff

Special Education and G&T

Students are eligible for all programs offered by the district.

Play Unified

Program run under the Special Olympics umbrella

Elementary and Middle Schools partnership with general education and students with IEPs through activities several times during the school year.

High school athletic endeavors including practices and games with other districts like Paramus. Social events with Belleville.

Tuition Paying Students

We accept tuition paying students in recognition that we can provide programs in the least restrictive environment. Only accepted if they are a match for our programs and there is room in the program as per state code.
