Under the direction of the Director of Curriculum, the teacher is responsible for delivering instruction around Science, Technology, Engineering, and Math (STEM) principles. Students will learn design thinking, project based learning, coding, and robotics.

- A. A valid Michigan elementary or middle school teaching certification
- B. Teaching experience in elementary or middle school grades
- C. Knowledge and experience in STEM, reading, and writing instruction
- D. Demonstrate the ability to use student data to inform instructional practices
- E. A demonstrated ability to communicate effectively—orally and in writing

- A. Previous experience teaching at the elementary or middle school level
- B. Previous experience in summer school, robotics, or project based learning
- C. Demonstrated success as collaborator and proven team player
