SDCOE Plan CC-C is an excellent baseline map and creates longitudinal oriented Areas 3 and 4 that better preserve unique characteristics of beach and inland communities. This is my preferred map with the following adjustments: 1. Please draw the boundary between Areas 1 and 3 along Santa Fe Road to keep the Cardiff School District and Encinitas Union School District communities intact. This will move San Dieguito Academy and the surrounding neighborhood into Area 1 so that they can stay together with their other other Ocean Knoll elementary school neighbors. 2. Now that Trustee Mossy has resigned, please delete her star so that the demographer can remove her home from consideration of Area 3 boundaries. I would prefer to see Rancho Santa Fe covenant in Area 4 and all of Del Mar west of I-5 in Area 3. I have emailed a markup of SDCOE Plan CC-C to visually represent my ideas. Thank you!
