No further notification from the School System will be required. **Non-payment (delinquency) of tuition will result in the student's immediate withdrawal from Pierce County Schools.** Any check returned by the bank will be considered non-payment and subject to a \$30.00 processing fee. The returned check and all future payments must be paid by cash or money order. The payment of tuition is a condition of enrollment. The obligation to pay tuition is unconditional, notwithstanding the subsequent dismissal, expulsion or withdrawal of the student.
