

IMPORTANT TAX INFORMATION

- Information on your tax account may be accessed by logging on to <https://www.texaspayments.com>. You may also pay by credit card on the website. There is a 4.0% convenience fee to pay by credit card or debit card. American Express fee is 4.0%. You may also do an e-check for \$5.00. Please be advised that there is a \$30.00 return check charge on all returned checks. PLEASE MAKE CHECKS PAYABLE TO MATHIS ISD.
- Taxes for the current year are due and payable in full on October 1, and are delinquent if not paid on or before January 31. State law requires that a penalty be charged on any taxes paid after January 31. THIS OFFICE WILL ACCEPT PARTIAL PAYMENTS UPON RECEIPT OF THIS STATEMENT. Delinquent taxes not paid prior to July 1 become subject to an additional 15% collection cost as provided under Section 33.07 of the Texas Property Tax Code.
- The Tax Collector does not have ANY legal authority to waive any penalty and interest on unpaid taxes. It is the responsibility of the taxpayer to see that the taxes are paid. If the payment is mailed, please do not assume that the taxes are paid. Penalty and interest cannot be waived on payments that were mailed and not received by the MATHIS ISD Tax Office or that were sent to an incorrect taxing entity in error by the taxpayer, mortgage or title company.
- Payments by mail are credited according to the U.S. Postmark, NOT METERS. Those bearing postmarks past deadlines will incur full penalty and interest charges. We recommend mailing early to assure a timely postmark to:

- Or you may pay your taxes in person at 410 E. San Patricio Ave., Mathis, Texas.
- If there is an error in value, exemptions, ownership, property description, or an address correction, please contact the San Patricio County Appraisal District at (361)364-5402, or the Bee County Appraisal District at (361)358-0193, or the Live Oak County Appraisal District at (361)449-2641 with the correct information. This correction will help see that the tax statements and appraisal notices are delivered in a timely manner.
- QUARTERLY PAYMENT OPTION FOR OVER-65 AND DISABLED PERSONS - If an over-65 exemption or disability exemption has been granted by the San Patricio County Appraisal District, or the Bee County Appraisal District, or the Live Oak County Appraisal District on your home, you may pay the current taxes in FOUR installments. You must pay at least one-fourth (1/4) of your taxes by January 31. The remaining payments are due on MARCH 31, MAY 31, and JULY 31, without penalty or interest. NO REMINDER NOTICES WILL BE SENT. If an installment payment is missed, a 6% penalty and also interest (at 1% for each month delinquent) will be added to that installment amount. Please indicate on each payment that it is an installment payment. Also note the tax account number on each installment payment.
- IF YOU ARE 65 YEARS OF AGE OR OLDER OR ARE DISABLED AND THE PROPERTY DESCRIBED IN THIS DOCUMENT IS YOUR RESIDENCE HOMESTEAD, YOU SHOULD CONTACT THE APPRAISAL DISTRICT REGARDING ANY ENTITLEMENT YOU MAY HAVE TO A POSTPONEMENT IN THE PAYMENT OF THESE TAXES.
- TAXPAYERS WITH AN OVER 65 EXEMPTION, A DISABILITY EXEMPTION, OR A DISABLED VETERANS EXEMPTION QUALIFY FOR AN INSTALLMENT PLAN ON THEIR RESIDENCE HOMESTEAD. PLEASE CALL FOR DETAILS.
