## Payment Choices

### OPTION 1 - FULL PAYMENT OF TUITION - 2.5% Discount off of Tuition amount

Full payment of tuition paid directly to the school by June 30, 2024 with a 2.5% discount on the tuition. (NO discount after June 30). If Payment is more than five days late, you will be required to make other arrangements.

There will be a 1% discount on tuition deducted from the December payment. If payment is more than five days late on either payment date, you will be required to make other arrangements.
