Waivers of State Statutes

FOUNDATIONS ACADEMY REQUEST FOR WAIVER OF COLORADO REVISED STATUTES

STATUTE

DESCRIPTION AND RATIONALE

C.R.S. § 22-9-106

Local Board of Education – Duties
Certificated Personnel Evaluations

This section requires that employee performance evaluations be performed by a person holding an administrative certificate (Type D).

Rationale: The Foundations Academy principal must have the ability to perform the evaluation of all personnel. Should the principal not have a Type D certificate from the State of Colorado, this should not preclude him or her from administering the evaluations.

Plan: NHA has a personnel evaluation processes and procedures consistent with the mission and goals of the school.

Duration of the Waivers: Foundations Academy requests that the waiver be for the duration of its contract with School District 27J.

How the Impact of the Waivers will be Evaluated: Since teacher performance has a critical impact on the performance of the entire school, the impact of this waiver will be measured by the same performance criteria and assessments that apply to the school.

Expected Outcome: With this waiver, Foundations Academy will be able to implement its program and evaluate its teachers in accordance with its own procedures. This will benefit staff members as well as students and the community.

STATUTE

DESCRIPTION AND RATIONALE

C.R.S. § 22-32-109 (l)(b)

Boards of Education – Specific Duties

Grants board of education the authority to adopt policies and prescribe rules and regulations for efficient administration of the district.

Rationale: Foundations Academy will be operating independently from other schools in the district and should be delegated the authority to develop, adopt, and implement its own operational policies, rules and regulations, subject to the limitations in the Charter School Application.

Replacement Plan: The Board of Directors of Foundations Academy will adopt policies and the Principal of Foundations Academy will prescribe rules and regulations.

Duration of the Waiver: Foundations Academy requests that the waiver be for the duration of its contract with School District 27J.

How the impact of the Waiver will be Evaluated: The impact of this waiver will be measured by the performance criteria and assessments that apply to Foundations Academy as set forth in this Charter School Application.

Expected Outcome: As a result of this waiver, Foundations Academy will be able to carry out its educational program, administer its affairs in an efficient manner, and accomplish its mission as set forth in the Charter School Application.

C.R.S. § 22-32-109 (l)(f) Boards of Education – Specific Duties
Requires the Board of Education to employ all personnel and fix their compensation.

Rationale: Foundations Academy will contract with National Heritage Academies to provide staff. NHA will employ staff and establish terms and conditions of employment, policies, rules and regulations, and provide training. Therefore, the school requests that these statutory duties be delegated from the School District 27J Board of Education to the principal of Foundations Academy. The success of Foundations Academy will depend in large part upon its ability to select and employ its own staff and to train and direct that staff in accordance with this Charter School Application and the goals and objectives of the school. All Foundations Academy staff will be employed by National Heritage Academies (NHA) on an at-will basis.

Replacement Plan: Foundations Academy will be responsible for these matters rather than the district.

Duration of the Waivers: Foundations Academy requests that the waivers be for the duration of its contract with School District 27J.

How the Impact of the Waivers will be Evaluated: The impact of the waivers will be measured by the same performance criteria and assessments that apply to Foundations Academy, as set forth in this Charter School Application.

Expected Outcome: As a result of these waivers, NHA will select, employ and provide professional development for its own teachers and staff, in accordance with the terms and conditions set forth in the Charter School Application.

C.R.S. § 22-32-109 (l)(t) Boards of Education – Specific Duties
Grants board of education authority to determine the educational program to be carried on in schools of the district and to prescribe textbooks.

Rationale: Foundations Academy should have the authority to determine the educational program and textbooks to be used.

Replacement Plan: The Foundations Academy educational program and curriculum is described in this Charter application.

Duration of the Waiver: Foundations Academy requests that the waiver be for the duration of its contract with School District 27J.

How the Impact of the Waiver will be Evaluated: The impact of this waiver will be measured by the performance criteria and assessments that apply to Foundations Academy, as per this Charter School Application.

Expected Outcome: Foundations Academy expects that as a result of this waiver it will be able to implement its curriculum and ensure that students meet the educational standards of Foundations Academy.

C.R.S. § 22-32-110 (1) (h) Local Board Powers
Makes Board of Education responsible for terminating personnel.

Rationale: Foundations Academy will contract for educational services with NHA. NHA will be responsible for its own personnel matters, including employing its own staff and establishing its own terms and conditions of employment, policies, rules and regulations, and terminating its own employees. Therefore, Foundations Academy requests that these statutory duties be delegated from the School District 27J Board of Education to the principal of Foundations Academy. The success of Foundations Academy will depend in large part upon its ability to select and employ its own staff and to terminate individual staff members should they not perform in accordance with this Charter School Application and the goals and objectives of the school. All Foundations Academy staff will be employed on an at-will basis.

Replacement Plan: Foundations Academy will be responsible for these matters rather than the district.

Duration of the Waiver: Foundations Academy requests that the waivers be for the duration of its contract with School District 27J.

How the Impact of the Waivers will be Evaluated: The impact of the waivers will be measured by the same performance criteria and assessments that apply to Foundations Academy, as set forth in this Charter School Application.

Expected Outcome: As a result of these waivers, Foundations Academy will select, employ and provide professional development for its own teachers and staff, in accordance with the terms and conditions set by this Charter School Application.

C.R.S. § 22-32-126 Employment & Authority of Principals

Authorizes Board of Education to employ Principals.

Rationale: Foundations Academy will contract for educational services with NHA. NHA will be responsible for its own personnel matters, including employing the principal, its own staff and establishing its own terms and conditions of employment, policies, rules and regulations, and providing its own training. Principals employed at Foundations Academy will be employed on an at-will basis. Therefore, Foundations Academy requests that these statutory duties be delegated from the School District 27J Board of Education to NHA. The success of Foundations Academy will depend in large part upon its ability to select and employ its own principal and staff in accordance with this Charter School Application and the goals and objectives of the school.

Replacement Plan: NHA will be responsible for these matters rather than the district.

Duration of the Waiver: Foundations Academy requests that the waivers be for the duration of its contract with School District 27J.

How the Impact of the Waivers will be Evaluated: The impact of the waivers will be measured by the same performance criteria and assessments that apply to Foundations Academy, as set forth in this Charter School Application.

Expected Outcome: As a result of these waivers, Foundations Academy will select, employ and provide professional development for its principal, teachers, and staff, in accordance with the terms and conditions set by the Charter School Application.

C.R.S. § 22-63-201
(substantive)

Employment – Certificate required

Prohibits board from entering into an employment contract with a person who does not hold a teacher’s certificate or letter of authorization.

C.R.S. § 22-63-402

Services – Disbursements

Prohibits disbursement of district monies to teacher without a valid teacher’s certificate, letter of authorization or written authorization.

Rationale: NHA should be granted the authority to hire teachers and principals that will support the schools goals and objectives. The Principal will not function as a traditional district school principal, but rather will be responsible for a wider range of tasks and act as the CEO of Foundations Academy. NHA will seek to attract principals and teachers from a wide variety of backgrounds, including, but not limited to teachers from out-of-state, teachers with a lapsed Colorado certificate, persons with several years of successful teaching experience in a setting not requiring a license, as well as persons with business or professional experience. All employees of NHA will be employed on an at-will basis.

Replacement Plan: NHA will, where possible, hire certified teachers and principals. However, in some instances it may be advantageous to be able to hire teachers and/or principals without a

Colorado certificate and who possess unique background and/or skills or fill the need of the School.

Duration of the Waivers: Foundations Academy requests that the waivers be for the duration of its contract with School District 27J.

How the Impact of the Waivers will be Evaluated: The impact of these waivers will be measured by the performance appraisal criteria and assessments that apply to Foundations Academy, as per this Charter School Agreement.

Expected Outcome: As a result of these waivers, the School will be able to employ professional staff possessing unique skills and/or background filling all staff needs.

C.R.S. § 22-63-202	<u>Teacher Employment – compensation and dismissal act of 1990</u> Provides for contracts to be in writing – duration – damage provision
C.R.S. § 22-63-203	<u>Probationary Teachers – renewal and non-renewal of employment contract – Specific Duties</u> Provides for contract with probationary teachers and allows for non-renewal and renewal of employment contract.
C.R.S. § 22-63-403	<u>Payment of Salaries</u> Governs payment of salaries upon termination of employment of a teacher.

Rationale: Foundations Academy will contract for educational services with NHA. NHA should be granted the authority to develop its own employment contracts and terms and conditions of employment. All employees of NHA will be employed on an at-will basis.

Replacement Plan: NHA will pay salaries upon termination of employment of a teacher consistent with at-will employment.

Duration of the Waivers: Foundations Academy requests that the waivers be for the duration of its contract with School District 27J.

How the Impact of the Waivers will be Evaluated: The impact of these waivers will be measured by the performance appraisal criteria and assessments that apply to Foundations Academy, as per this Charter School Application.

Expected Outcome: As a result of these waivers, Foundations Academy will be able to employ professional staff possessing unique skills and/or background, filling all staff needs.

C.R.S. § 22-63-206	<u>Teacher Employment, Compensation and Dismissal Act</u>

Permits transfer of teachers between schools upon recommendation of district's chief administrative officer.

Rationale: Foundations Academy will contract for educational services with NHA. NHA should be granted the authority to select its own teachers. The district should not have the authority to transfer teachers into Foundations Academy or transfer teachers from Foundations Academy to district schools or any schools outside the district.

Replacement Plan: Foundations Academy will hire teachers on a "best qualified" basis.

Duration of the Waiver: Foundations Academy requests that this waiver be for the duration of its contract with School District 27J.

How the Impact of the Waiver will be Evaluated: The impact of this waiver will be measured by the performance criteria and assessments that apply to Foundations Academy, as set forth in this Charter School Application.

Expected Outcome: Foundations Academy expects that as a result of this waiver it will be able to manage its own personnel affairs.

C.R.S. § 22-63-301 Transfer Employment, Compensation and Dismissal Act
Grounds for dismissal.

C.R.S. § 22-63-302 Procedures for dismissal of teachers.

Rationale: The success of Foundations Academy in accomplishing its mission is dependent primarily upon the talents, skills and personal commitment of its teachers. NHA must be able to terminate employees who cannot deliver its educational program successfully. The concept of tenure does not apply to NHA. All employees of NHA will be employed on an at-will basis.

Replacement Plan: Continued employment in Foundations Academy shall be subject to an annual satisfactory performance evaluation. Teachers who are rated unsuccessful may be terminated by NHA.

Duration of the Waivers: Foundations Academy requests that the waivers be for the duration of its contract with School District 27J.

How the Impact of the Waivers will be Evaluated: The impact of these waivers will be measured by the performance criteria and assessments that apply to Foundations Academy, as set forth in this Charter School Application.

Expected Outcome: As a result of these waivers, Foundations Academy will be able to provide instruction in accordance with the philosophy and mission as stated in this Charter Proposal.

C.R.S. § 22-63-401 Transfer Employment, Compensation and Dismissal Act

Provides for district board of education to adopt a salary schedule and place teachers on the schedule.

Rationale: Foundations Academy will contract for educational services with NHA. NHA should be delegated the authority to determine compensation rates, in accordance with its policies. The workday and work year in Foundations Academy may be different from that of the District and compensation must be adjusted accordingly.

Replacement Plan: NHA has its own pay schedule.

Duration of the Waiver: Foundations Academy requests that the waivers be for the duration of its contract with School District 27J.

How the impact of the Waiver will be Evaluated: The impact of this waiver will be measured by the performance criteria and assessments that apply to Foundations Academy as set forth in this Charter School Application.

Expected Outcome: As a result of this waiver, Foundations Academy should be able to attract qualified personnel and provide instruction in accordance with the philosophy and mission as stated in this Charter Proposal.
