**CONTRACT FOR DUAL ENROLLMENT FOR
EXTRACURRICULAR ACTIVITIES/SPORTS.....PROCEDURE #630.1-P2**

Definition of Extracurricular Activity/Sport: This includes any regularly scheduled interscholastic activity recognized as sanctioned by IHSAA.

This contract is made and entered into on the _____ day of _____, 20____, between _____, herein after referred to as “Public Charter/Private/Home School”, and Middleton School District #134, hereinafter referred to as “Middleton District”, and collectively referred to in this contract as “Parties”.

The Parties agree as follows:

1. The Public Charter/Private/Home School students are eligible to be dual enrolled in extracurricular activities based on the same criteria as Middleton District students.
2. The Public Charter/Private/Home School agrees to pay fees for its/their students enrolled in extra-curricular activities as follows:
 - Middleton Middle School: \$100 per each activity/sport with a per student cap at \$300 annually
 - Middleton High School: \$200 per each activity/sport with a per student cap at \$400 annually
3. All students will be required to make application for dual enrollment participation in extracurricular activities. The Public Charter/Private/Home School will provide their students, who wish to participate in a Middleton District extra-curricular activity/sport, with the Middleton District application for Dual Enrollment for Extracurricular Activities/Sports (Procedure 630.1-P1)
4. All fees and costs of dual enrollment participation in extracurricular activities/sports must be received prior to the 1st event/game of the season for each activity/sport in which the student will be participating.
5. No fee shall be assessed for any Public Charter/Private/Home School student who is cut from an extracurricular activity/sport due to ability or the Middleton District dropping the activity/sport.
6. The contract shall be in full force for the _____ - _____ school year and will terminate July 1, _____.
7. The provisions and stipulations of this Contract shall insure to and bind the heirs, executors, administrators, assigns and successors in interest of the parties hereto.
