As a district, we are interested in having higher levels of academic achievement which is inextricably connected to students' literacy levels. Districtwide, only 45% of students are reading at or above grade level, based on the 2022 SBAC. The TK-12 Schools Department must focus on increasing our site administrators' skill set in being strong instructional leaders, leading the implementation of the literacy initiative, consulting data to make decisions, and providing the environment teachers and staff need to deliver quality instruction to students.
