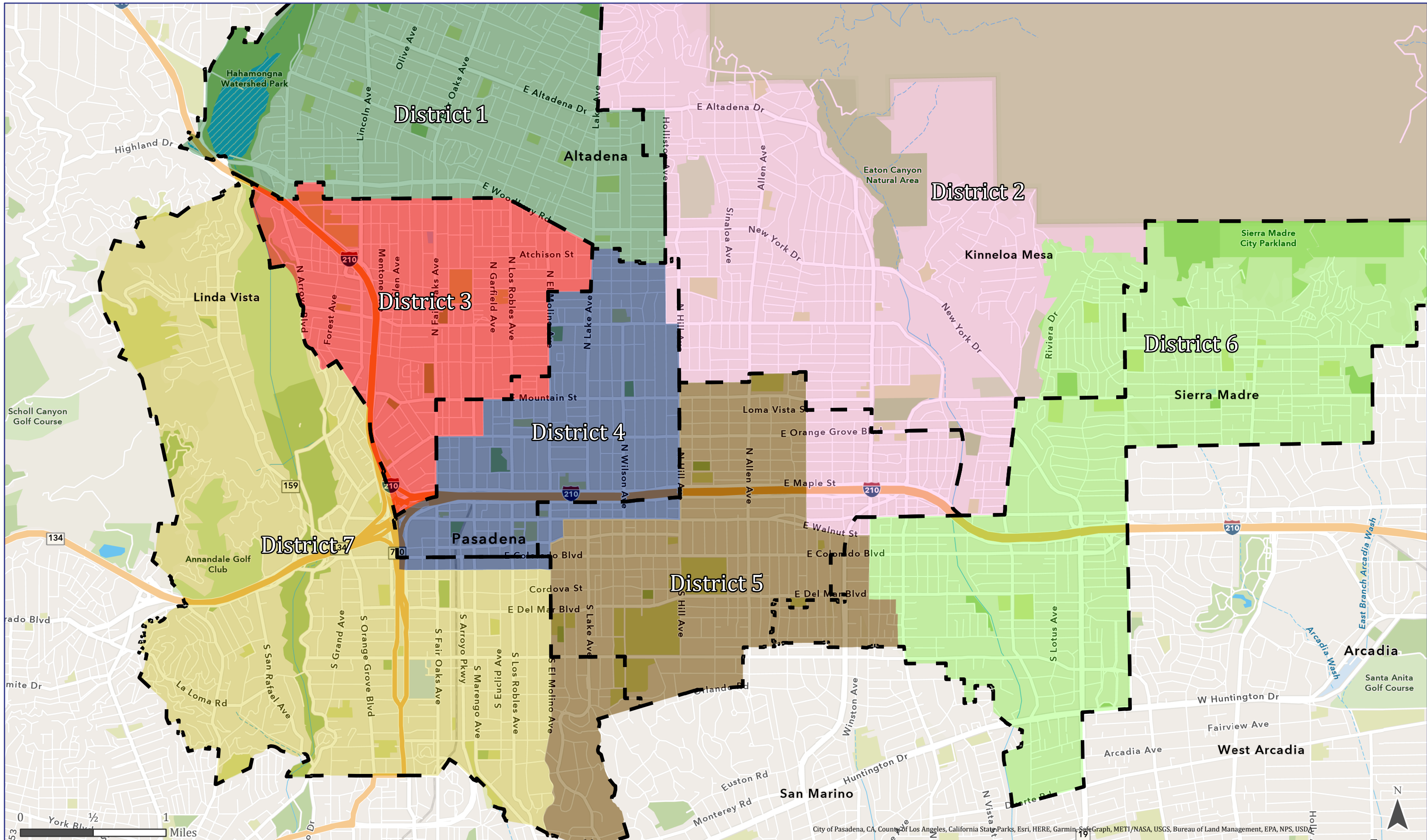


EXHIBIT B: PLAN BOUNDARY DESCRIPTIONS
