 - State Revenues down by more than \$41.2 Billion Dollars
 - Impact to Education Budget (Prop 98) approximately \$18 Billion

COVID 19 RELIEF FUNDS

- SB117 \$267,885
- FEMA-Have applied and awaiting assignment of case manager Currently have over \$3660K in expenses and growing
- CARE (Education Stabilization)
 - 18002-Governor's Emergency Education Relief (GEER)
 - Competitive
 - 18003-Elementary & Secondary Emergency Relief Fund (ESSER)
 - Estimated \$4.6 mil
- Title I Carry-over flexibility
- Title IV Flexibility with technology limits

Approved Uses of Additional Funding Sources

- Distance learning systems
- PD to support distance learning
- Health/Safety/Supplies
- Access and support student groups facing barriers



Possible Budget Flexibility

- Allow Flexibility on the use of unspent S& C funds
- Reduce or suspend the required 3% Routine Restricted
 Maintenance transfer
- Reduce or suspend the required Reserve for Economic Uncertainty for the outer years
- Provide relief for the next two years for increases in STRS and PERS
- Freeze districts ADA at their Feb 29, 2020 counts for the next two years or using enrollment instead of ADA
- Reduce the instructional days from 180 to 175 statewide.



Budget Requirements

- 2020-21 budget required to be adopted by June 30, 2020
 - LCAP extended until December 15, 2020
 - Must provide report regarding distance learning
- Based on estimates from the Governor's May Revision
- State will likely not finalize their budget until August
 - State and Federal income tax filings and payments extended until July 15, 2020
- District may need to revise budget once the State budget is signed
