Question from COC member Hammack: How is the lowest <u>responsible</u> bidder providing services so much lower than the other bidders.

Response from SafeworkCM: They understood the scope and others assumed architectural efforts were to be included.

Question from COC member Uriu: Do they have experience with older campuses and as most schools have similar prices that are very different. Response from SafeworkCM: Yes, they are familiar with all PUSD campuses and they have been on each site so priced on that knowledge.

Question from COC member Uriu: Project will move without this ADA survey Response from SafeworkCM: Yes, the project will proceed without the ADA survey such as the shade structures.

C. 1657 F Marshall Fundamental Secondary School – Softball Field Renovation Project

There was a significant conversation by COC members including the "walkway location" but the final recommendation was to send the BR to the Board. SafeworksCM indicated that it had been addressed but the drawing was not attached to the BR package.

D. 1662-F Approval to Proceed with Preparation of Bids and Procurement for the John Muir Modernization Project

The COC asked about what parents and students will do during construction. Home games will have to be played away at other locations and the principals have been informed. Practices will be at the location. Budget has been provided for transportation of students athletics for practices and home games.

There was a significant conversation by COC members due to the background of the BR but the final recommendation was send the BR to the Board.

Football field restrooms are not included but rather modernization of both gyms, boys and girl's restrooms, two pools to one pool, pool areas, wet utilities and HVAC. Facilities will be modernized and not completely gutted to preserve facilities that have been incorporated already.

E. 1663-F Approval to Proceed with Preparation of Bids and Procurement for the Madison ES Modernization Project

There was a significant conversation by COC members due to the background of the BR but the final recommendation was send the BR to the Board.

Transportation Plan has to be developed to move students to Allendale ES or Franklin ES since it can hold the student body. Roosevelt ES is not large enough

for Madison ES student body. It is not a part of this BR costs. Looking to change Madison ES from an early start to a late start for this 1 year modernization.

Facilities will be modernized and not completely gutted to preserve facilities that have been incorporated already.

F. 1664-F Approval to Proceed with Preparation of Bids and Procurement for the Longfellow ES Modernization Project

There was a significant conversation by COC members due to the background of the BR but the final recommendation was send the BR to the Board.

Transportation Plan has to be developed to move students to Allendale ES or Franklin ES since it can hold the student body. Roosevelt ES is not large enough for Longfellow ES student body. It is not a part of this BR costs. Looking to change Longfellow ES from an early start to a late start for this 1-year modernization.

The COC asked about what parents and students will do during construction. Swing space has been determined in order to complete the construction.

Facilities will be modernized and not completely gutted to preserve facilities that have been incorporated already.

G. 1665-F Approval to Proceed with Preparation of Bids and Procurement for the Summer Projects for Wet Utilities for Eliot Arts MS, Sierra Madre ES, and Willard ES

There was a significant conversation by COC members due to the background of the BR which has projects estimated at approximately \$16M and rewording is needed as to how these projects will be grouped. The attachments to the BR outlines the 3 phase of modernization and in between those is a prioritization of other projects. This attachment being proposed by PUSD staff has to be reviewed, discussed and approved by the Board in order for BR-1665-F to move forward.

The final recommendation was to send the BR to the Board.

H. 1666-F Approval to Proceed with Preparation of Bids and Procurement for Deferred Maintenance and Minor Repairs related to Fire, Life, and Safety at Eliot Arts MS, San Rafael ES, Sierra Madre ES, and Willard ES

There was a significant conversation by COC members due to the background of the BR which has total projects estimated at \$40M and rewording is needed as to how these projects will be grouped. This \$40M will be addressed at \$6.6M over 6

District Priority/Strategy: Implementation of Measure O Bond Capital Projects

#### I. BACKGROUND:

Pasadena High School received a three-phased modernization as part of Measure TT and the campus identity and front entrance modernization work were not constructed due to the budget constraints. The work not performed included a new entry canopy at Building A, school front irrigation and landscaping, minor fencing, new flagpole, and accessibility upgrades.

Project Scope:

- 1) Construction of new front entry canopy at Admin (Bldg. A) to define main entrance to the building, and expansion of existing interior lobby.
- 2) Install new ramps and colored concrete walkways to comply with new ADA requirements, and to provide better aesthetics for the campus frontage.
- 3) Install new landscaping and irrigation in front and throughout campus area.
- Replace existing doors and windows at Admin Bldg. south facade, facing Sierra Madre Blvd.
- 5) Minor configuration of perimeter fencing at front of the school between Admin/Auditorium Bldg.
- 6) New Flagpole to replace existing.

#### II. STAFF ANALYSIS:

The Board is requested to authorize Facilities Staff to proceed with preparation of Bids and Procurement for Pasadena High School Campus Identity Modernization Project.

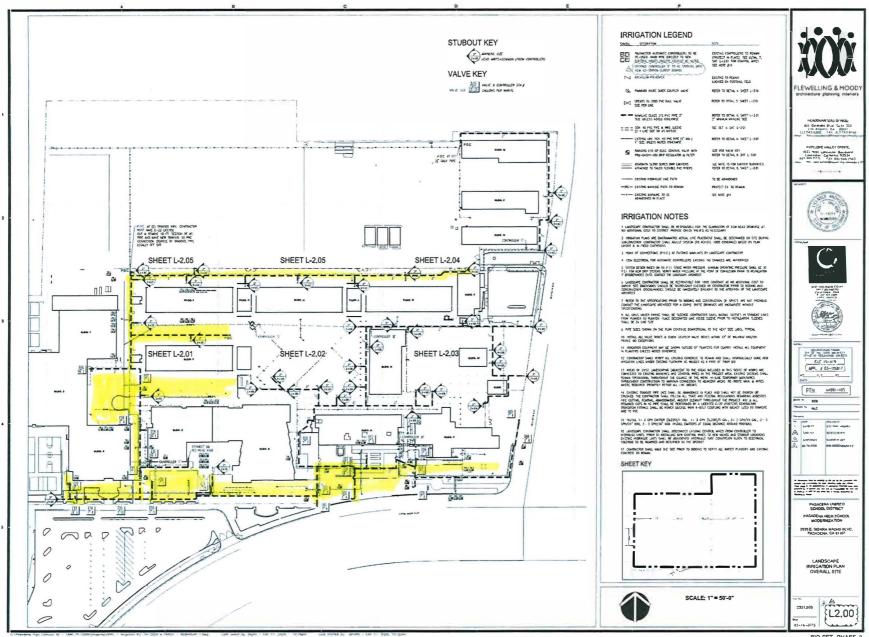

5. <u>TIME FOR COMPLETION</u>: The District may give a notice to proceed within ninety (90) days of the award of the bid by the District. Once the Contractor has received the notice to proceed, the Contractor shall complete the work in the time specified in the Agreement. By submitting this bid, Contractor has thoroughly studied this Project and agrees that the Contract Time for this Project is adequate for the timely and proper completion of the Project. Further, Contractor has included in the analysis of the time required for this Project, Rain Days, Governmental Delays, and the requisite time to complete Punch List.

In the event that the District desires to postpone giving the notice to proceed beyond this ninety (90) day period, it is expressly understood that with reasonable notice to the Contractor, giving the notice to proceed may be postponed by the District. It is further expressly understood by the Contractor, that the Contractor shall not be entitled to any claim of additional compensation as a result of the postponement of giving the notice to proceed.

If the Contractor believes that a postponement will cause a hardship to it, the Contractor may terminate the contract with written notice to the District within ten (10) days after receipt by the Contractor of the District's notice of postponement. Should the Contractor terminate the Contract as a result of a notice of postponement, the District shall have the authority to award the Contract to the next lowest responsible bidder, if applicable.
