Azusa USD & Citrus College Partnership

Assembly Bill 288 - College & Career Access Pathways Partnership Agreement (CCAP): offering or expanding dual enrollment opportunities for high school students who may not already be college bound or who a

opportunities for high school students who may not already be college bound or who are underrepresented in higher education, with the goal of developing seamless pathways from high school to community college for career technical education or preparation for transfer, improving high school graduation rates, or helping high school pupils achieve college and career readiness.

- Dual Enrollment and Concurrent Enrollment
- Articulated Career Technical Education (CTE) courses (students take AUSD high school courses and can receive college credit if they pass the end of course exam)
- Offer non-college credit courses for high school credit recovery
- Enrollment/Registrations Sessions
- Campus Visits

What is Dual Enrollment & Early College?

- Dual Enrollment (DE): student is enrolled as both a high school and college student. This allows high school students to take college classes while they are still enrolled in high school.
- Early College Program (ECP): designed to allow students to complete <u>college</u> General Education requirements before leaving high school.
- Dual Credit: students earn credits for both high school and college graduation.



Additional Benefits

- College Credits Earned: transferable and accepted by all California State (CSU) and University of CA (UC) schools (note: may not be accepted by private and/or out of state colleges/universities)
- Different from AP/IB courses: There is no single test to determine if the class counts for college
- Students can take AP/IB courses along with the ECP and graduate with more than two years of college credits

Additional Benefits

- High School Grade Point Average (GPA): all college courses are weighted. For example, an "A" grade will factor as a 5.0 for the GPA.
- College admission officers know ECP students are college ready since they have already passed multiple college courses with a "C" or higher
- No Cost FREE! Students do not pay for tuition, fees, or books.



Cost of Colle University

(Nationwide statistics/data)

- The average cost of college by more than doubled in the 21st century, with an annual growth rate of 2%.
- The average in-state student attending a public 4-year institution spends \$26,027 for one academic year.
- The average cost of in-state tuition alone is \$9,678; out-of-state tuition averages \$27,091.
- The average private, nonprofit university student spends a total of \$55,840 per academic year, \$38,768 of it on tuition and fees.
- Note: UC tuition approx. \$14,436 per year; CSU tuition approx. \$6,084 per year

Associate Degree for Transfer for Freshmen

<u>ADT</u>- Associate Degree for Transfer: designed to provide a clear pathway for California community college students to California State University (CSU) degrees. California community college students who earn an associate degree for transfer are guaranteed admission with junior standing to select CSU campuses and are given priority admission consideration over other transfer students.

AUSD and Citrus College has determined to build a program focused on an ADT in Sociology (SOC), the systematic study of social behavior and human groups.

- Popular major and serves as a good foundation for studies in social sciences
- Courses are designed to help students understand the structure, processes, and functions of society, the key theoretical approaches and insights that inform sociology, and the role of social theory and research methods in understanding society
- Students majoring in this field can continue studying SOC once they transfer. If students want to change their major, the general education courses they take for their ADT in SOC will likely apply to the new majors.

What is IGETC? (pertains to both Freshmen and Juniors)

Details

- All Early College Program classes will be held at Azusa High School
- 4 Year commitment (Freshman), 2 Year commitment (Juniors) including summer school starts June 2024
- Dedicated AUSD counselor to support
- Students can earn as much as 34 60 transferable college credits
- Courses taught by instructors hired by Citrus College
- Some courses might be taught by AUSD teachers who are qualified to teach for Citrus College

- Regular School Year:
 - □ ECP classes usually meet 2 days a week (for example, M/W or Tu/Th)
 - College classes are only 1 semester long (students take 2 courses a semester)
 - Schedule will be released late Spring/Early Summer 2024 (dependent on instructor availability)
 - □ Students will be on a different schedule than other students (for example, start time for Freshman is 7:30am_)
 - Students will still be able to take all the classes, electives, & activities offered to non-ECP students (dependent on the master schedule)

Requirements Incoming Freshman

- Middle School GPA of 2.5 or better
 No Fs for 8th grade semester report cards
- Two Recommendations from 8th grade teachers (through a Google Form)
- Interview with AUSD staff / Alumni (TBD)

- If accepted:
 - Complete Citrus College online registration process
 - Complete dual enrollment form
 - Parents Sign FERPA Waiver and consent that their student can take a college course via an online form



Requirements Incoming Juniors

- High School Academic GPA of 2.5 or higher HP/AP courses (not mandatory but will help identify students who are used to rigorous courses)
- Counselor/Teacher Review
- Interview with AUSD staff / Alumni (TBD)

- If accepted:
 - Complete Citrus College online registration process
 - Complete dual enrollment form
 - Parents Sign FERPA Waiver and consent that their student can take a college course via an online form



Attributes

- Strong work & study habits

Expectations

- 2 or 4 year commitment, including summer school
- Earn a grade of "C" or better in each course
- Adhere to all deadlines and fulfill all requirements
- Communicate effectively and directly with Citrus College instructor
- Extensive out of class commitment, including HW and studying

Your family must discuss and agree that this commitment is best for the student

Important Information

- Your student is considered a Citrus College student, and by FERPA guidelines, Citrus College is restricted from providing confidential information or communicating to anyone but the student.
 - Parents <u>DO NOT</u> have direct access to student's grades or instructor
- Student's grades are part of permanent college transcript
 - □ DROP/WITHDRAWAL(W) or FAIL(F): part of student's permanent academic record that transfers to any post-secondary institution. (It is better to withdraw from a class rather than fail.)
 - □ Adhere to DROP/WITHDRAWAL process, dates, and deadlines
- Students **DO NOT** graduate early from high school just because they are participating in the Early College Program.

FERPA
