The assistant will forward your email to all Committee Members prior to the meeting. Comments will be read aloud as written, so please keep written comments to 750 words or less. If a member of the public would like an item placed on the agenda, please contact the District Office. In accordance with Education Code 35145.5, the Committee cannot enter into a formal discussion or make a decision on any matter not on this agenda during this meeting. The Committee may take action to refer any subject discussed in a presentation at this Committee meeting to a later meeting.
