The Pleasant Valley School District Citizens' Oversight Committee (COC) regular meeting will be a teleconference meeting where one or more members of the Committee will be attending the meeting via teleconference/video conference.

The Governor has declared a State of Emergency to exist in California as a result of the threat of COVID-19 (aka the "Coronavirus"). The Governor issued Executive Order N-25-20, which directs Californians to follow public health directives including canceling large gatherings. The Executive Order also allows local legislative bodies to hold meetings via conference calls while still satisfying state transparency requirements.

The Public's health and well-being are the top priority for the Citizens' Oversight Committee ("COC") of Pleasant Valley School District ("District") and you are urged to take all appropriate health safety precautions. In order to minimize the spread of the COVID-19 virus, the District office will not be open to the public. Public comments will be taken in person at the PVSEA Early Education Center (EEC) located at 550 Temple Avenue, Camarillo, CA. The sheet should be presented to the assistant prior to the start of the meeting or prior to the start of the Public Comments section of the agenda. Individual speakers will be allowed three minutes to address the Committee. Public Comments may also be emailed to the assistant at [vpatrik@pleasantvalleysd.org](mailto:vpatrik@pleasantvalleysd.org) at least twenty-four hours prior to the start of the meeting. The assistant will forward your email to all Committee Members prior to the meeting. Comments will be read aloud as written so please keep written comments to 750 words or less. If a member of the public would like an item placed on the agenda, please contact the District Office. In accordance with Education Code 35145.5, the Committee cannot enter into a formal discussion or make a decision on any matter not on this agenda during this meeting. The Committee may take action to refer any subject discussed in a presentation at this Committee meeting to a later meeting.
