President Coers asked Recording Secretary, June Isselhardt, to read the results of the School Board and Referendum Election.

There are 19,043 registered voters. Of the 19,043 registered voters, only 7,082 people cast a ballot. John Coers received 3,107 votes, John Wagnon received 4,290 votes, Todd Roach

received 4,745 votes, Steve Springer received 4,005 votes and Chris Pulcher received 3,852 votes.

There were 7,082 ballots cast regarding the Referendum, 2,479 voted yes and 4,517 voted no.

Moved by Richter, seconded by Baskett, to accept the canvas of votes as read and declare Todd Roach, John Wagon, Steve Springer, and Chris Pulcher the winners and the Referendum as failed. Roll call. All voted aye. Motion carried.

Moved by Richter, seconded by Drury, to adjourn the meeting. All voted aye. Motion carried. Adjournment time was 5:35 p.m.
