(i) carruurta iyo dhalinyarada oo laqeybsanayo deegaan dadkale sababta oo ah gurila'aan, dhibaato dhaqaale, ama wax lamid ah; ama ey dagan yihiin hotel, trailer parks, ama camping grounds u keentay iney heli waayen hoy; ama ey degen yihiin guri kusii sug ah; isbitaalada iska yaala; ama sugaaya meelaynta daryeelka korinta.

(ii) carruurta iyo dhalinyarada qaba deganaansho habeenkii in uu yahay meel dadweyneama gaar ah aan loogu talagalay ama caadiyan loo isticmaalo sida hoy ah hurdada caadiga ah aadanaha (gudahood macnaha qaybta 103 (a) (2) (C));

(iii) carruurta iyo dhalinyarada ku nool baabuurta jardiinooyinka meelaha dadweynaha, guryaha la dayacay, guryaha aan ladayactirin, saldhigyada bas ama tareen, ama meelaha la midka ah; iyo

(iv) carruurta guur guurta (shuruudaha lagu qeexay qaybta 1309 ee Xeerka Waxbarashada Hoose iyo Sare ee 1965) u qalma sida guri la'aan u ahayn ujeedooyinka wax ka mid ah Cinwaan sababtoo ah carruurta ku nool xaalado ku qeexan qodobo (i) ilaa (iii).
