The Board of Education of the City School District of the City of Cincinnati, Ohio, met pursuant to its calendar of meetings in the ILC at the Cincinnati Public Schools Education Center, 2651 Burnet Avenue, Monday, January 9, 2023, at 5:48 p.m., President Lindy in the chair.

SUPERINTENDENT'S UPDATE

Superintendent Wright: Addresses the speculation that Schedule E process at school level stipend been received but the budget is being cut at Walnut Hills. Wright stated this is not true and the principal was asked to clarify that so that everyone received the right information. Wright believes that in the next budget year that the Schedule E stipend amounts will need to be reviewed. Wright showed recognition and support to the School Board Members for the School Board Month. They each received an "I am present" button, and a certificate from the Ohio School Board Association.

Lee (Fine Arts Teacher at SCPA) wanted to speak regarding Schedule E who is hearing from his colleagues in the district budgets for schools raised to match the stipends being raised that were discussed in the negotiations.

Julie Sellers (CFT President) wanted to speak about Schedule E that it was a problem last year and is again this year. She stated they did increase it but they did not increase the budget to the schools. Because budget and staffing are being determined at the time she wanted to remind the Board of the importance of Reading, Math and ELA Specialist.
